Dear Mr. Kingsley:

On September 27, 1999, the NRC completed an inspection at your Braidwood Units 1 and 2 reactor facilities. The enclosed report presents the results of that inspection.

During the 6-week period covered by this inspection, your conduct of activities was generally characterized by safety-conscious operations, sound engineering and maintenance practices, and careful radiological work controls.

However, we were concerned about several observations by the inspectors that station personnel were not in compliance with plant administrative procedures or work instructions. There were two Non-Cited violations in this report involving the failure to follow procedures. Management efforts to ensure compliance with plant administrative procedures have not been completely effective.

Based on the results of this inspection, the NRC has determined that two violations of NRC requirements occurred. These violations are being treated as Non-Cited Violations (NCVs), consistent with Appendix C of the Enforcement Policy. These NCVs are described in the subject inspection report. If you contest the violation or severity level of these NCVs, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001, with copies to the Regional Administrator, Region III, and the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-001.
