WATTS BAR NUCLEAR PLANT (WBN) UNITS 1 AND 2 - SECURITY PERSONNEL TRAINING AND QUALIFICATION (T&Q) PLAN, REVISION 3

Pursuant to 10 CFR 50.54(p)(2), this letter provides Revision 3 to the WBN T&Q Plan which supersedes the T&Q Plan dated April 12, 1999, and subsequently submitted May 21, 1999. The enclosed Revision 3, dated September 20, 1999, adds a physical fitness qualification test for armed members of the Security Force who are not response personnel. This revision also reformats the entire document. TVA has evaluated these changes and does not consider this revision to decrease the overall effectiveness of the plan.

Enclosed are four copies (NOS. 6 through 9) assigned to the NRC. Copies 10 and 11 are being provided to Region II by copy of this letter.
