CE NPSD- 1157, Elimination of Post Accident Sampling System (PASS) requirements

The CEOG plans to discuss the review schedule.

CE NPD-396-P, Common Qualified Platform, Phase 2

The focus of this topic is the effect of changing NRC reviewers on the schedule.

Pressure Temperature Limits Report (PTLR)

The CEOG will discuss the acceptance review process for submittals; specifically as it applied to the PTLR submittal.

CENPD-388-P, OPTIN Burnup to 65 Mwd/KgU

The CEOG plans to discuss the review schedule.

GSI-23, Reactor Coolant Pump (RCP) Seal Integrity

The issue is applicability of industry RCP seal integrity model to CEOG plants.

**IV. NRC Topics**

Laser Welded Steam Generator Sleeves in CE Plants

The staff will discuss certain actions on the part of licensees needed to bring future laser welded sleeve installations into compliance with the code.

GSI-165, Safety Relief Valves

The issue is the potential for failure of safety relief valves to affect the functionality of emergency core cooling system.

**V. Progress Report on Risk Informed Initiatives**

The Chairman of the Probabilistic Safety Assessment Subcommittee (PSASC) will provide an update on the CEOG risk informed projects.
