SUBJECT: SUMMARY OF THE OCTOBER 27, 1999 MEETING BETWEEN
 THE SPENT FUEL PROJECT OFFICE STAFF AND THE
 TOOELE COUNTY, UTAH, COMMISSIONERS

On October 27, 1999, staff from the Spent Fuel Project Office met with members of the Tooele County, Utah, Commission, and their Washington area representative. An attendance list is attached. The Tooele County Commissioners requested this meeting to discuss the application for the proposed Private Fuel Storage Facility (PFSF). The application was submitted by Private Fuel Storage, L.L.C. (PFS), a consortium of nuclear utilities. PFS proposes to build the PFSF, an away-from-reactor independent spent fuel storage installation, on the reservation of the Skull Valley Band of Goshute Indians, a Federally-recognized Indian Tribe. The reservation is geographically located within the borders of Tooele County.

The Commissioners were interested in a gaining a better understanding of the duration of the license and whether the facility would be the responsibility of PFS or the U.S. Department of Energy (DOE). They stated that they were aware of DOE's previous Monitored Retrievable Storage initiative and wanted to be sure that they understood the differences between that program and the PFS proposal. The Commissioners also discussed the economic situation in Tooele County and their experience in dealing with several hazardous waste facilities and the Envirocare Low-Level Waste facility, which are all currently located in Tooele County.

No regulatory decisions were requested or made at this meeting, and no follow-up actions are required of the staff.

I would be happy to discuss this meeting further with you.
