SUBJECT: REVISION 3 AGENDA FOR CRGR MEETING NO. 350

The Committee to Review Generic Requirements (CRGR) will meet on Thursday, November 18, 1999, from 2:00 p.m. to 4:00 p.m., in room T4B3. This meeting was originally scheduled for October 26, and then October 29, 1999. The agenda is as follows:

- 2:00 p.m. - 3:00 p.m. D. Matthews (NRR) will brief the CRGR on the proposed Draft Regulatory Guide DG-1093: "Guidance and Examples for Identifying 10 CFR 50.2 Design Bases." This briefing is for information, not disposition.
- 3:00 p.m. - 4:00 p.m. Bruce Boger (NRR) will present for CRGR review and endorsement the draft final proposed Regulatory Guide DG-1082, "Assessing and Managing Risk Before Maintenance Activities at Nuclear Power Plants."

If a CRGR member cannot attend the meeting, it is his or her responsibility to ensure that an alternate, who is approved by the CRGR Chairman, attends the meeting. Persons making presentations to the CRGR are responsible for (1) ensuring that the information required for CRGR review is provided to the Committee (CRGR Charter - IV.B); (2) coordinating and presenting views of other offices; (3) as appropriate, ensuring that other offices are represented during the presentation; (4) forwarding, by e-mail or overnight mail, a copy of the presentation material to CRGR regional member, Jon Johnson, RII, who would be participating via video-conferencing; (5) forwarding by e-mail the incoming review request, background material, if available, and presentation material to Janice Moore, the Committee's OGC member; and (6) ensuring that agenda modifications are coordinated with the CRGR contact (Raji Tripathi, 415-7584 or George Lanik, 415-7490) and others involved with the presentation. Sponsoring Division Directors or higher management should attend meetings addressing agenda items under their purview.
