## OFFICE OF ENFORCEMENT NOTIFICATION OF SIGNIFICANT ENFORCEMENT ACTION

(IA 99 -047)

Subject: ORDER PROHIBITING INVOLVEMENT IN NRC-LICENSED ACTIVITIES (EFFECTIVE IMMEDIATELY)

This is to inform the Commission that a Confirmatory Order Prohibiting Involvement in NRC-Licensed Activities (Effective Immediately) will be issued on or about October 22, 1999, to Jasen Mallahan, an unlicensed individual formerly employed by Professional Service Industries, Inc., an NRC licensee, as a radiographer. This action is based on an NRC inspection and investigation which concluded that Mr. Mallahan engaged in deliberate misconduct in violation of 10 CFR 30.10, which caused the licensee to be in violation of NRC requirements. Specifically: (1) Mr. Mallahan was directly involved in deliberately failing to conduct radiography with at least two qualified individuals to observe operations, which caused the licensee to be in violation of 10 CFR 34.41(a); and (2) Mr. Mallahan failed to supervise a radiographer's assistant while performing radiographic operations, which caused the licensee to be in violation of 10 CFR 34.46.

The Order requires, in part, that: (1) Mr. Mallahan is prohibited from engaging in NRC-licensed activities, which include those activities pursuant to the authority granted by 10 CFR 150.20, for one year from the effective date of the Order; and (2) within 20 days of his acceptance of each employment offer involving NRC-licensed activities during a period of one year following the one-year prohibition, Mr. Mallahan provide written notice to the NRC of the name, address, and telephone number of the NRC licensee.

It should be noted that the individual has not been specifically informed of the enforcement action. The schedule of issuance and notification is:

The individual has twenty days from the date of the Order in which to request a hearing.
