ENFORCEMENT ACTIONS


Dear Mr. Krich:

We anticipate that this may take several weeks. The Region III office will provide a copy of the predecisional enforcement conference transcript, which should be available shortly. We understand that you will provide a copy to Mr. Landrum.

You also requested an extension of time to reply to the enforcement action on behalf of ComEd and Mr. Landrum. This letter extends the time for both ComEd and Mr. Landrum to reply to 30 days after the date of the NRC letter forwarding that last of the requested documents.
