SUBJECT: SECURITY PLANS, REVISION 31

Dear Mr. Maynard:

This letter acknowledges receipt of your letter dated August 31, 1999, which transmitted Revision 31 to the Wolf Creek Generating Station Physical Security Plan, Safeguards Contingence Plan, and Training and Qualification Plan submitted under the provisions of 10 CFR 50.54(p).

Based on your determination that the changes do not decrease the effectiveness of your Physical Security Plan, Contingency Plan, and Training and Qualification Plan, and after limited review of the changes, no NRC approval is required in accordance with 50.54(p). We did not identify any violations of 10 CFR 50.54(p) during our review. Implementation of these changes will be subject to inspection to confirm that the changes have not decreased the effectiveness of these security plans.

During our review of Revision 31 it was identified that the last (added) sentence to the definition of "Central Alarm Station," on page xiii, could be misinterpreted. On November 22, 1999, D. Erbe of your staff advised D. Schaefer of this office, that this definition would be clarified in a subsequent change to the security plan.

The enclosures to your letter contain Safeguards Information as specified in 10 CFR 73.21 and are being withheld from public disclosure.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.


