Dear Mr. Dugger:

This refers to NRC Inspection Report 50-382/99-17 dated November 4, 1999. Our staff has determined that after mailing, two errors were identified in the report. The purpose of this letter is to correct the docket.

Section S1.1 of the Report Details described a noncited violation (50-382/9917-03) for failure to provide positive identification and verification of access authorization prior to granting access to the protected area. A vulnerability in the security computer allowed two individuals to gain access to the protected area under the access authorization of two other individuals. The first incident occurred on June 28, 1999, and the second on July 20, 1999. The incident that occurred on June 28, 1999, was discussed in NRC Inspection Report 50-382/99-13 dated July 15, 1999. The corrective action for this noncited violation was not successful in preventing the second failure. The noncited violation contained in NRC Inspection Report 50-382/99-17 should only have described the violation that occurred on July 15, 1999.

It is also noted that the heading of the executive summary portion of the report identified the report as NRC Inspection Report 50-382/99-01. It should have read NRC Inspection Report 50-382/99-17.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room (PDR).
