Dear Mr. Barron:

This refers to the inspection conducted between September 12, 1999, and October 23, 1999, at McGuire Nuclear Station. The enclosed report presents the results of that inspection.

During the six-week period covered by this inspection, your conduct of activities at the McGuire Nuclear Station was generally characterized by safety-conscious operations, sound engineering and maintenance practices, and careful radiological work controls.

Based on the results of this inspection, the NRC has identified an additional example of Violation 50-369,370/98-07-07, concerning inadequate vendor oversight of emergency diesel generator refurbishment. This additional example is described in the subject inspection report. If you contest our disposition of this matter, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001, with copies to the Regional Administrator, Region II, the Resident Inspector at the McGuire Station, and the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001.

In accordance with 10 CFR 2.790(a) of the NRC's "Rules of Practice," a copy of this letter, its enclosure, and any response you choose to make will be placed in the NRC Public Document Room.

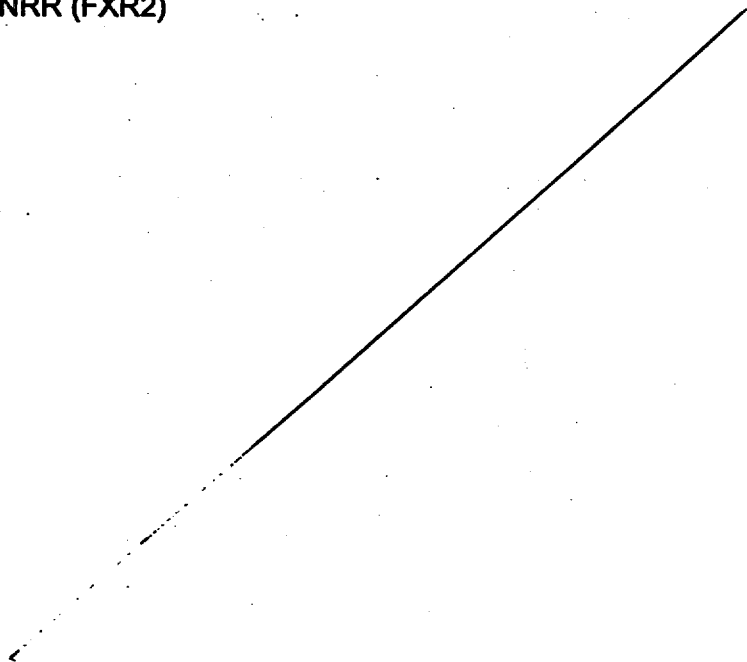
