Dear Mr. Powell:

In accordance with The Freedom of Information Act, 5 U.S.C. 552, and the provisions of 10 CFR Part 9, as amended, we request copies of any documents in your possession which relate to any or all of the following descriptions:

1. All documents submitted by Stone & Webster Engineering Corporation or the licensee regarding Surry 1 and 2, Maine Yankee, Fitzpatrick, or Beaver Valley Power Station No. 1 in response to I.E. Bulletin 79-14 concerning small bore piping (piping 2 ½ inches or less in diameter).
2. All documents submitted by Stone & Webster Engineering Corporation or the licensee regarding Surry 1 and 2, Maine Yankee, Fitzpatrick, or Beaver Valley Power Station No. 1 in response to I.E. Bulletins 79-02 or 79-14 concerning large bore piping seismic capability or seismic stress analysis (piping 2 ½ inches or more in diameter).
3. All documents from whatever source regarding revisions, amendments or changes to I.E. Bulletin 79-14.

4. All documents pertaining to "reportable incidents" (including Licensee Event Reports or "LER"s) involving Category I piping, and, in particular, piping supports at Surry 1 and 2, Maine Yankee, Fitzpatrick, or Beaver Valley Power Station No. 1.
