Correction to the Cover Letter Regarding Changes to Technical Specifications  
Updating List of Documents Describing the Analytical Methods Specified in  
Technical Specification 6.9.1.8b**

Northeast Energy Company (NNECO) proposed to amend Operating License DPR-65 by incorporating proposed changes into the Millstone Unit No. 2 Technical Specifications in a letter dated November 23, 1999.<sup>(1)</sup> On page 2 of the letter dated November 23, 1999, under "Schedule", NNECO incorrectly stated "We request issuance of this amendment prior to restart from refueling outage 13, which is currently scheduled in early June of 1999, with the amendment to be implemented within 30 days of issuance." The correct date for refueling outage 13 is currently early June of 2000. NNECO is requesting that the above mentioned statement be replaced with: "We request issuance of this amendment prior to restart from refueling outage 13, which is currently scheduled in early June of 2000, with the amendment to be implemented within 30 days of issuance." This correction is an administrative correction to the content of the cover letter. It has no impact on the proposed changes to the Millstone Unit No. 2 Technical Specifications provided in the letter dated November 23, 1999.

There are no regulatory commitments contained in this letter.
