Public Comment on NRC "scoping" for release from central policy (64 FR 125, 35090 6/30/99)

The standard must be given indication from nuclear power and weapons production. Radioactive waste and materials cannot be "neglected" at the expense of public health and safety. These materials are not below regulatory concern. There are unknowns. BNF L has been increasing regulatory requirements in the US and it makes me nervous! Their "track record" with the YSC-24 and T market calls to what I am most familiar with, and it is almost so far! Then promise to "clean up" after Soviet nuclear finance have not been kept. So why should I expect better performance in their other operations in nuclear business in this country? The only reason BNF L would be buying up all these reactors is if they think they can make a profit by selling the "neglected" materials. The lack of public scrutiny and the ~~extensive~~ process of NPL internal to me is a recipe for disaster — just as was the leading of the first T market call at T major.
