The purpose of this modification is to:

1. Exercise the third option year of the contract in accordance with Federal Acquisition Regulation Clause 52.217-9, entitled, "Option to Extend the Term of the Contract," and Contract Clause A.4, entitled, "Duration of Contract Period." As a result of this action, the firm fixed price of the contract is hereby increased by \$100,590.00 from \$298,455.00 to \$399,045.00.
2. Amend Attachment 3 of the contract entitled, "Electronic Redistribution Site License Agreement," to incorporate services for Nuclear News Flashes in accordance with McGraw-Hill's addendum to the agreement dated, November 12, 1999, which is made a part hereof. The period of performance for this service shall be January 1, 2000, through December 31, 2000, at no additional cost to the Government.

Accordingly, the contract is hereby modified as follows:

- (1) Subsection A.4, Duration of Contract Period is deleted in its entirety and the following is substituted in lieu thereof:

"A.4 DURATION OF CONTRACT PERIOD

The period of performance for this contract shall commence on January 1, 1997, and will expire on December 31, 2000. The term of this contract may be extended at the option of the Government for an additional one-year period."

- (2) Subsection B.3, Consideration and Obligation is deleted in its entirety and the following is substituted in lieu thereof:

"B.3 CONSIDERATION AND OBLIGATION -- FIRM FIXED PRICE (JUN 1988)

The firm fixed price of this contract is \$399,045.00."

- (3) Under Section C, Contract Documents, Exhibits, or Attachments, Attachment 3, Electronic Redistribution Site License Agreement is amended to include the services specified in the attachment to this modification.
