Dear Mr. Reandeau:

By Order dated November 24, 1999, the Nuclear Regulatory Commission (NRC) approved the transfer of the license for the Clinton Power Station (CPS) held by Illinois Power Company (IP) to AmerGen Energy Company, LLC, and approval of a conforming amendment pursuant to Sections 50.80 and 50.90 of Title 10 of the Code of Federal Regulations. The Order was published in the Federal Register on December 2, 1999 (64 FR 67598). By letter dated December 2, 1999, AmerGen notified the NRC that all required regulatory approvals of the transfers have been received, and that the closing of the transfer will occur on December 15, 1999. The letter of December 2, 1999, satisfies the required conditions of the Order.

Accordingly, the Commission has issued the enclosed Amendment No. 123 to Facility Operating License No. NPF-62 for CPS. The conforming amendment reflects the transfer of IP's ownership and operation of CPS to AmerGen. The safety evaluation supporting the conforming amendment was attached to the above mentioned Order, issued on November 24, 1999.

The Notice of Issuance will be included in the Commission's biweekly Federal Register notice.
