W.M. Schlosser is hereby directed to give immediate effect to the sixth floor mechanical, electrical and architectural changes identified below. All work is to be performed in accordance with the base contract specifications except as noted herein. Modifications should be recorded in the As-Built drawings.

MECHANICAL CHANGES

1. Install two (2) additional return air registers.
2. Install two additional supply air registers.
3. Relocate five (5) existing thermostats to avoid conflict with furniture installation.

ELECTRICAL CHANGES

1. Delete installation of twenty-three (23) outlet drops (ceiling to Transwall base).
2. Delete installation of sixty-one (61) outlet extensions.
3. Delete installation of six (6) furniture outlets (labor only).
4. Delete installation of four (4) eight conductor furniture junction boxes.
5. Relocate installation of sixteen (16) existing light fixtures.
6. Relocate installation of two (2) junction boxes that conflict with mechanical installations.
7. Provide forty (40) linear feet of EMT conduit and wire necessary to feed new furniture junction box locations.
8. Replace three (3) missing set of conductors in three (3) conduit runs along columns at 2E, 1H and 7C.
9. Provide ten (10) additional elbow connectors for furniture junction boxes.

ARCHITECTURAL CHANGES

1. Install 20 linear feet of "box-out" around ceiling obstructions.

W.M. Schlosser is requested to provide a proposal for adjustment within twenty calendar days of the effective date of this change order. Upon completion of negotiations, a supplemental agreement will be issued to incorporate an equitable adjustment for these changes.

Except as provided herein, all other terms and conditions remain unchanged and in full force and effect.
