The purpose of this modification is to (1) increase the obligated amount by \$10,000; and (2) extend the period of performance. The contract is therefore modified as follows:

1. Under Section B.3, Consideration and Obligation--Cost Plus Fixed Fee (JUN 1988), paragraph (c) is deleted in its entirety and replaced with the following:
 - (c) The amount obligated by the Government with respect to this contract is \$643,100.00.

2. Section F.2, Duration of Contract Period, is deleted in its entirety and replaced with the following:

"This contract shall commence on July 22, 1997 and will expire on June 30, 2000."

A summary of obligations for this contract, from date of award through the date of this action, is given below:

Total FY98 Obligations:	\$ 164,100
Total FY99 Obligations:	\$ 294,000

This modification obligates funds in the amount of \$10,000.00.

All other terms and conditions, including the ceiling of \$703,151.96, remain the same.
