SUBJECT: H.R. 4482 - THE NUCLEAR POWER PLANT SAFETY ENHANCEMENT
ACT

On May 17, 2000, Representative Sue Kelly (R-NY) introduced H.R. 4482, the Nuclear Power Plant Safety Enhancement Act. The bill would establish within the Office of the Inspector General of the NRC a unit to be charged with auditing the safety analysis and review activities of the Commission and personnel of nuclear power plants licensed by the Commission. The bill has been referred to the House Committee on Commerce. No hearings have been scheduled. Attached for your information is a copy of H.R. 4482.

Mrs. KELLY introduced the following bill; which was referred to the Committee on Commerce

A BILL

To establish within the Office of the Inspector General of the Nuclear Regulatory Commission a unit to be charged with auditing the safety analysis and review activities of the Commission and personnel of nuclear power plants licensed by the Commission.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

This Act may be cited as the 'Nuclear Power Plant Safety Enhancement Act'.

SEC. 2. AUDIT OF SAFETY ANALYSIS AND REVIEW ACTIVITIES.

Title II of the Energy Reorganization Act of 1974 is amended by adding at the end the following:

‘AUDIT OF SAFETY ANALYSIS AND REVIEW ACTIVITIES

‘SEC. 212. There shall be established within the Office of the Inspector General of the Commission a unit which shall audit the safety analysis and review activities of the Commission and personnel of nuclear power plants licensed by the Commission.’.

SEC. 3. AUTHORIZATION OF APPROPRIATIONS.

There are authorized to be appropriated such sums as may be necessary for the implementation of the amendment made by section 1.
