ORDER
(Scheduling Matters)

Upon consideration of (1) the joint agreement of applicant Private Fuel Storage, L.L.C. (PFS), intervenor State of Utah (State), and the NRC staff regarding (a) review of claimed proprietary information that is part of the evidentiary record of this proceeding relative to contention Utah E/Confederated Tribes F, Financial Assurance, including the transcripts of the June 20, 21, 22, and 27, 2000 closed hearing sessions and the parties' exhibits relating to that contention, see Tr. at 1410-19, 2681-82, and (b) transcript corrections for the June 19-22 and June 27, 2000 evidentiary hearings on contentions Utah E/Confederated Tribes F, Utah R, Emergency Planning, and Utah S, Decommissioning, see id.; and (2) the July 12, 2000 PFS and staff responses to the intervention petition and contentions of petitioner William D. Peterson, it is

ORDERED, that on or before Monday, September 11, 2000, PFS, the State, and the staff shall provide the Board with (1) a joint filing outlining any agreements regarding (a) what portions of the closed session transcripts and the exhibit materials relating to contention Utah E/Confederated Tribes F can be placed on the public record, and (b) transcript corrections

relating to the June 19-22, 2000, and June 27, 2000 evidentiary sessions; and (2) individual party filings seeking evidentiary material disclosures or transcript corrections about which the parties' do not agree; and it is

FURTHER ORDERED, that petitioner Peterson shall have up to and including Monday, July 24, 2000, within which to file a reply to the responses of PFS and the staff regarding his intervention petition and contentions. The Board notes that it does not intend to conduct an oral argument regarding this petition.

The filings required or permitted under this order should be served on the Board, the Office of the Secretary, and counsel for the other participants by facsimile transmission, e-mail, or other means that will ensure receipt by midnight Eastern Time (ET) on the day of filing.
