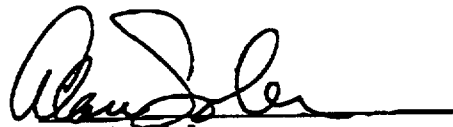
DECLARATION OF DR. ALAN SOLER
