Dear Mr. Lohaus:

As a result of e-mail correspondence with Mr. Stephen Solomon of your staff, we discovered that we have not received from the NRC a letter stating its concurrence with **Part T, Transportation of Radioactive Material**. In keeping with your letter dated May 8, 1998, four changes were made to the body of Part T:

Sec. T.4a. was changed to read "The most current version of the US Postal Service Domestic Mail Manual (DMM), Section C-023.9.0."

Sec. T.8b.i. was changed to read "fabrication of the package is satisfactorily completed by April 1, 1999."

Sec. T.19d. & e. were changed to stipulate records be retained by the licensee for 3 years.

Appendix A, Table IV, the activity stated for C-244 was changed to 8.1E+01 Ci/g.

Further, the following paragraph was inserted into the 1999 Rationale:

"The various provisions of the 10 CFR Part 71 regulation are assigned different compatibility and health and safety categories. Definitions of each category and the specific category assigned to each provision of 10 CFR Part 71 are set out in US Nuclear Regulatory Commission, Office of State Programs Internal Procedure B.7, Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements. They reflect the new adequacy and compatibility policy statement approved by the Commission by Staff Requirements Memorandum dated June 30, 1997 (see also 62 FR46517)."

A copy of Part T was sent to your office on March 3, 1999. The 1999 version of Part T included all of the above changes per NRC's recommendations. CRCPD has subsequently published Part T to all State Programs.
