Dear Mr. Holonich:

Enclosed is the fourth progress report entitled, "Site Characterization Progress Report: Yucca Mountain, Nevada, Number 4," for October 1, 1990-March 31, 1991 (Enclosure 1). The report is transmitted for your information to show the progress of site characterization activities at Yucca Mountain, Nevada. The report covers a number of initiatives to improve the effectiveness of the site characterization program, and covers continued efforts related to the preparatory activities, study plans, and performance assessment.

In accordance with the understanding between the U.S. Department of Energy (DOE) and the U.S. Nuclear Regulatory Commission (NRC) as conveyed via DOE letter (Shelor to Linehan) dated June 17, 1991, the DOE is to provide copies of documents cited in the progress reports "that are not available through the open literature, published symposia proceedings, or the standard channels for distribution of government reports." 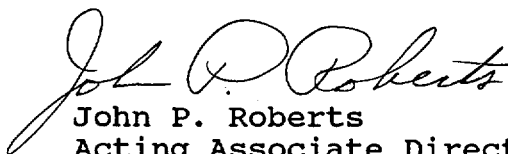
