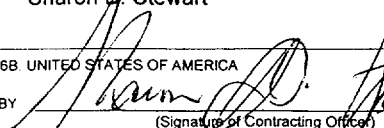

1. Subsection B.8, "CONSIDERATION AND OBLIGATION - - WORK ORDERS (JUN 1988)," paragraph (b), first sentence, is hereby deleted in it's entirety and substituted with the following in lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$96,500.00."
