Warn, whose patience and courage helped defeat the low level nuclear waste dump for seven Southern states planned for Wake-Chatham border; Rev. Carrie Bolton, pastor at Alston Chapel Church in Pittsboro, recognized for her work in opening a daycare and summer camp program for black children; Lewis Pitts, a lawyer advising Warn, who works for North State Legal Services, a non-profit organization dedicated to helping provide legal services to those who might not be able to afford them. On December 3 NC Warn is sponsoring a rally at 3 P.M. at the Shearon Harris plant in New Hill, with music, speeches, puppets. December 6 we have an opportunity to hear one of the scientists, Gordon Thompson, speak at The Chapel Hill Town Hall at 7:30 P.M. on the risk of a major nuclear accident in the Triangle. Thompson and David Lochbaum have been prevented by CP & L's lawyers from giving their testimony before the Nuclear Regulatory Commission board which will make the decision about whether this doubling of nuclear waste in the heart of the Triangle is safe. Then December 7 you can witness the CP & L and Orange County lawyers presenting their cases before the NRC board in the McKimmon Center at NCSU, beginning at 9:30 A.M.
