Dear Mr. Ogata:

Thank you for your September 15, 2011 letter in response to the Notice of Violation (NOV) that was discussed in the subject U.S. Nuclear Regulatory Commission (NRC) inspection report (IR).

We have reviewed your letter and found that it is generally responsive to the NOV. However, certain aspects of your response need to be addressed in further detail. You are required to respond to this letter and should follow the instructions specified at the end of this letter when preparing your response.

Your response to NOV 05200021/2011-201-02 regarding unapproved changes being made in the field by the AREVA test engineer was found to be inadequate because it does not address the cause for Mitsubishi Heavy Industries' (MHI) failure to verify that changes to the test procedure were being reviewed and approved as the original document as required by AREVA Document 56-9141754, "Quality Assurance Program."

Please provide a written statement or explanation to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, DC 20555-0001 with a copy to the Chief, Quality and Vendor Branch 1, Division of Construction Inspection and Operational Programs, Office of New Reactors, within 30 days of the date of this letter. This reply should be clearly marked as a "Reply to a Notice of Violation" and should include: (1) additional explanation to address the violation, or if contested, the basis for disputing the violation; (2) the corrective steps that have been taken and the results achieved; and (3) the date when your corrective action will be completed. Where good cause is shown, consideration will be given to extending the response time.

In accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 2.390 of the NRC's "Rules of Practice," a copy of this letter and your response will be made available electronically for public inspection in the NRC Public Document Room or from the NRC Agencywide Documents Access and Management System, accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>. To the extent possible, your response should not include any personal privacy, proprietary, or safeguards information so that it can be made available to the Public without redaction. If personal privacy or proprietary information is necessary to provide an acceptable response, then please provide a bracketed copy of your response that identifies the information that should be protected and a redacted copy of your response that deletes such information. If you request that such material is withheld from public
