SUBJECT: Co-60 Contaminated Metal Tissue Box Holders

Dear Mr. O'Connor

This refers to our telephone conversation on January 20, 2012, the submittal of your waste management plan dated January 23, 2012, and emails through February 6, 2012, outlining the pickup schedule and ultimate transfer/disposal for the contaminated tissues boxes from your stores. After review of the information provided by Bed, Bath and Beyond, Inc. (BBBY), we have concluded that appropriate actions have been implemented to secure and ultimately dispose of approximately 220 Dual Ridge metal boutique tissue holders found to be contaminated with cobalt 60 (Co-60).

Based on the information provided by BBBY, the contaminated metal tissue box holders will be collected and disposed by transfer to an authorized recipient as provided in 10 CFR 30 or equivalent Agreement State requirements or transfer for disposal to a licensed low-level waste land disposal facility as provided in 10 CFR 20.2001 and 10 CFR 20.2006 or equivalent Agreement State requirements. This process is scheduled to be completed by September 2012.

It is our understanding that you intend to dispose of or transfer this material in accordance with applicable NRC and Agreement State regulatory requirements. Please notify us in writing when you have accomplished this disposal or transfer. If you are unable to dispose of or transfer the Co-60 contaminated metal tissue holders, you will need to apply for and obtain a radioactive materials license from either the NRC or an Agreement State to continue to possess this radioactive material.
