Hi Jennifer,

On Tuesday, Scott Elkins sent Hossein Nourbakhsh the SOARCA NUREG (Rev 1) for ACRS review in preparation for the June 21 ACRS meeting on SOARCA.

This morning, Scott called me. He is off today, but he wanted to let me know that Kathy and he developed a version of the SOARCA NUREG (Rev 2) for the ACRS to review instead of Rev 1. Rev 2 differs from Rev 1 in at least 3 ways:

- the Executive Summary has been removed
- part of the Executive Summary has been appended to the end of the NUREG as a new chapter (Chapter 6)
- Sandia has made other changes in response to NRC staff comments

Scott asked me to check with you regarding whether you want us to proceed with sending Rev 2 to Hossein Nourbakhsh today.

Please note that Jimi is not in today, and neither Charlie nor I have reviewed Rev 2.
