NOTICE OF VIOLATION

Dear Ms. Faunce:

Thank you for your letter dated December 21, 2011, submitted in response to our October 25, 2011, letter and Notice of Violation. The violations concerned: (a) failure to store byproduct waste bins within a restricted area, as required by a license condition; (b) failure to provide the NRC with copies of excursion and spill reports that had been reported to the State of Wyoming, as required by a license condition; and (c) failure to have an alarm to notify wellfield operators that an exceedence had occurred, as required by the license application. We have reviewed your reply and find it responsive to the concerns raised in our Notice of Violation. We will review the implementation of your corrective actions during a future inspection to determine that full compliance has been achieved and will be maintained.
