14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to increase the obligated amount by \$128,000 from \$1,556,000 to \$1,684,000. Accordingly, paragraph (c) of Section B.3 of the contract entitled: "Consideration and Obligation Cost Plus Fixed Fee (JUN 1988) Alternate I (JUN 1991) is revised to read as follows:  
"(c) The amount currently obligated by the government with respect to this contract is \$1,684,000, of which the sum of \$1,568,543.61 represents the estimated reimbursable costs and of which \$115,456.39 represents the fixed fee."

All other terms and conditions remain the same.
