SUBJECT: SUMMARY OF PUBLIC LICENSE RENEWAL OVERVIEW AND ENVIRONMENTAL SCOPING MEETINGS RELATED TO THE REVIEW OF THE GRAND GULF NUCLEAR STATION LICENSE RENEWAL APPLICATION (TAC NOS. ME 7385 AND ME 7386)

The U.S. Nuclear Regulatory Commission (NRC or the staff) conducted license renewal process overview and environmental scoping meetings related to the review of the Grand Gulf Nuclear Station (GGNS) license renewal application submitted by Entergy Operations, Inc. Two public meetings were conducted on Tuesday, January 31, 2012, at the Port Gibson City Hall in Port Gibson, Mississippi. Approximately 30 people attended the meetings. The attendees included representatives of the NRC, members of the public, local and State government officials, and representatives from Entergy Operations, Inc. Public comments included concerns regarding emergency preparedness and aging management.

A combined listing of attendees for both public meetings is provided in Enclosure 1. Enclosure 2 is a copy of the meeting handouts provided during the public meeting open house.
