SUBJECT: PEER REVIEW AUDIT FINDINGS FOR 3Q11 AND 4Q11

The peer review audit of inspection reports for the 3rd and 4th quarters of FY 2011 has been completed. The following is a summary of the enclosed report.

Audit Requirements:

This audit was a review of three inspection reports for accuracy and compliance with Manual Chapter 0610. Specifically, three inspection reports generated during the 3rd and 4th quarters of FY 2011 were audited for compliance in the following five categories: timeliness of report issuance, content outline, adequate support of conclusions, use of SI units, and public availability in ADAMS.

Audit Findings:

All reports audited were in compliance in all categories reviewed, with the exception that two of the reports failed to use of SI units, as required by Appendix E of MC 0610.
