Field Office Inspection

Temporary Job Site Inspection Great Lakes Naval Base, North Chicago, IL

PROGRAM SCOPE

The was a respicity inspection of an Illinois State Licensee in a federal facility. The licensee is a small engineering firm. The licensee possessed one Troxler moisture density gauge at the site, for use daily/weekly during the construction season (May-November) for soils engineering projects. The licensee does not perform any service or maintenance activities on its gauges; these services are performed by the manufacturer. Device was secured in a licensee's pickup truck using a locked cover over the bed of the truck along with a lock and chain for the gauge case inside of the locked and secured truck bed. The licensee conducted leak tests for all gauges including the gauge observed on January 6, 2012.

Performance Observations

The inspector observed operations at a temporary jobsite at the North Chicago Naval base At the time of this inspection, the gauge was not in use. The operator possessed required shipping papers which contained all appropriate information and were accessible in the transport vehicle. Gauge/case were locked and chained to the rear of the vehicle during transport. The operator demonstrated an adequate level of understanding of emergency and handling procedures during job-site interviews. Security during transport and at the job-site was described and observed respectively with no problems noted.
