SUBJECT: FEBRUARY 6, 2012, NEI DROP-IN VISIT MEETING SUMMARY

PURPOSE

To provide Nuclear Energy Institute (NEI) with an overview of the process that the staff uses to review and update physical security Nuclear Power Plant NUREGs, Regulatory Guides (RG), and Standard Review Plans (SRP), to include the staff schedule to solicit stakeholder and public comments on the documents.

Doug Huyck, Branch Chief, Division of Security Policy, Security Programs Support Branch, welcomed the NEI Staff and introduced the Program Coordinator, James Vaughn, and the other Project Managers, Kelly Grimes and Kris Jamgochian.

James Vaughn delivered a brief review of the update process for NUREGs, RGs and SRPs as well as the roles and responsibilities that the other U.S. Nuclear Regulatory Commission (NRC) Offices (Office of Administration, Office of Nuclear Regulatory Research, and Office of New Reactors) have within that process. NEI was advised that the RGs that fall under the Division 5 series for Power Reactors are the main focus and are reviewed for update every five years; NUREGS are reviewed every three years; and SRPs, which provide standardized review practices in order to help reduce RAIs, are reviewed every two years. The RGs that have been identified as outdated and/or guidance has been embodied in more recent RGs will be considered for withdrawal pending agreement to do so by the other NRC Offices and the Regions.

In closing, Doug Huyck welcomed NEI to provide NRC feedback relative to any documents that are causing problems for the licensees. If so, they can be prioritized accordingly. Dave Klein stated he applauds the NRC staff for their efforts and that the licensees can do a good job if they have good guidance. NEI will provide the names of contacts for interface within their organization, once they are determined.
