(DOCKET NO. 40-06563, LICENSE NO. STB-401)

Dear Ms. Duft:

By letter dated February 7, 2012, (ADAMS No. ML12045A151) Mallinckrodt LLC (Mallinckrodt) requested that the U.S. Nuclear Regulatory Commission (NRC) amend Source Materials License No. STB-401 to reflect an intercompany reorganization that resulted in Mallinckrodt Inc. being converted to a limited liability company, Mallinckrodt LLC. The reorganization was completed on June 23, 2011, and resulted in no other organizational changes being made to the licensed entity or its ultimate parent company, Covidien, plc.

The NRC staff has completed its review of Mallinckrodt's amendment request and supporting documents, and determined that the request is complete and adequate. The basis for the staff's finding is documented in previous correspondence with Mallinckrodt dated May 26, 2011 (ADAMS No. ML111470850), July 1, 2011 (ADAMS No. ML11193A063), July 5, 2011 (ADAMS No. ML112010617), July 7, 2011 (ADAMS No. ML11196A053), July 7, 2011 (ADAMS No. ML111870050), July 26, 2011 (ADAMS No. ML11210B414), and January 30, 2012 (ADAMS No. ML113050517). Based on the staff's review, Source Materials License No. STB-401 is amended as requested (see enclosure). An environmental review was not conducted since this action, a change to the licensee's name, is categorically excluded under 10 CFR 51.22 (c)(10).

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice for Domestic Licensing Proceedings and Issuance of Orders," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS).
