In § 19.13(b) the reporting of annual doses to workers would be limited to those whose annual dose exceeds the dose threshold for providing instructions to workers. This would result in the elimination of an unnecessary reporting burden. In §§ 20.1003 and 50.02 the definition of TEDE would be revised to improve clarity in the regulations. Under the revision to § 20.1905, nuclear power licensees would not be required to label containers holding licensed material located in a posted area, if they are conspicuously marked and their accessibility is limited. Finally, the requirement in § 20.2104(a) that licensees attempt to obtain the records of a worker's lifetime dose would be removed except in specific circumstances.
