Status of Recommendations

<u>Recommendation 4:</u> Develop a standardized data collection process that can be used as the basis of an information sharing tool on a national level.

Agency Response Dated

January 26, 2011: To address the recommendation, in April 2010, the U.S. Nuclear Regulatory Commission (NRC) issued a questionnaire to Agreement States in order to obtain input on the willingness to share certain information; estimates of the annual burden to share the information; and the legality of sharing the information from the State perspective (RCPD 10-006, ML100750102). NRC staff analyzed the data. Based on the responses received from the Agreement States, NRC staff concluded that a voluntary, password protected database on the Office of Federal and State Materials and Environmental Management Programs public website that includes data involving bans, revocations, suspensions, and denials was the most suitable option due to several States' laws. On June 16, 2011, NRC staff issued a letter to the Agreement States seeking voluntary information to build a national enforcement database (RCPD-11-009, ML111380479). With the data received from the Agreement States, the database was built and tested. On November 8,

2011, the database was made available for Agreement State

However, NRC will strongly encourage all Agreement States to contribute to this effort and share valuable information that could assist fellow regulators in making informed decisions. The staff has completed the planned actions with regard to

and NRC use (RCPD-11-019, National Enforcement Database Web Site Now Available To Registered Users, ML113040320). As previously mentioned, NRC cannot require Agreement States to provide this information.
