2/14/2012 (09:00) I spoke with the receptionist who indicated that Janos Kovacs was not in the office and asked if I could be transferred to his voice-mail. I requested to be transferred to someone in administration rather than leaving a message on the voice-mail. The individual I was transferred to stated I should speak with Robert Miske. I inquired whether she could transfer me to Eugene Digioia and was told that he no longer worked for the company. I left a message for Mr. Miske to contact me.

(11:40) Ms. Barlow called on behalf of Mr. Kovacs and Light Sources, Inc. I informed her that the purpose of the phone call was to provide an exit meeting from the inspection conducted on January 20, 2012. However, in order to close out the inspection, I would need to speak to the management of Light Sources. I asked if Ms. Barlow knew that the RSO had left the company and whether she had any idea as to why. She stated that she did not know the RSO had left the company.

2/16/2012 (11:30) Mr. Kovacs returned my call. I informed Mr. Kovacs that my management and that at headquarters had gone over my findings and gave me the "go-ahead" to issue the clear letter. NRC Headquarters is continuing to work on the application for the "E" license and if they have any questions they will get back to the licensee shortly. I inquired about the circumstances behind Mr. Digioia leaving the employ of the licensee. Mr. Kovacs stated that Mr. Digioia had received a very good offer from another company but agreed to help transition the new RSO into the position over the next six months. Ms. Barlow would be coming to the licensee's facilities next week to provide training to Robert Miske and, once completed, an amendment request for a new RSO would be submitted to the NRC for review. I thanked Mr. Kovacs for the information.
