Dear Sir or Ma'am:

We request the Nuclear Regulatory Commission (NRC) consolidate license number SUC-1391, issued to Tooele Army Depot, Tooele, Utah, into license number SUC-1380 issued to the US Army Joint Munitions Command, Rock Island, Illinois. This action will terminate the SUC-1391 license and the SUC-1380 license will assume responsibility for licensed material and operations at Tooele Army Depot. We have enclosed a memorandum from Tooele Army Depot to the Joint Munitions Command with a date of August 1, 2012 requesting consolidation of the two licenses. We have also enclosed the letter Tooele Army Depot sent to NRC Region IV on August 1, 2012.


The SUC-1391 and SUC-1380 licenses are for depleted uranium ammunition items and both authorize the same storage, handling, and logistic operations. Tooele Army Depot has been listed as a bulk storage installation in the SUC-1380 license for several years.

This license consolidation will reduce the total number of Army licenses by one, reduce annual license fees paid by the Army, and eliminate the current redundancy in license coverage at Tooele Army Depot.

The SUC-1380 license will continue to identify Mr. Kelly Crooks as the radiation safety officer and Mr. Gary Buckrop as the alternate radiation safety officer. Although there are no changes in radiation safety personnel at Tooele Army Depot, the SUC-1380 license does not identify radiation safety personnel at installations.

MEMORANDUM FOR Commander, Joint Munitions Command (JMC), AMSJM-SF
(Mr. Buckrop), 1 Rock Island Arsenal, Rock Island, IL 61299-6000

SUBJECT: Consolidation of Nuclear Regulatory Commission (NRC) Licenses

1. References:

- a. Tooele Army Depot (TEAD) NRC License SUC-1391, issue date 25 July 2006.
- b. JMC NRC License SUC-1380, issue date 10 May 2004.
2. We request consolidation of the licenses referenced above. The consolidation of the TEAD license into the JMC license will eliminate redundancy and cut costs as both licenses authorize operations for depleted uranium (DU) penetrator type munitions. The DU ammunition operations currently authorized by the TEAD license would fall under the JMC license and we will terminate the TEAD license. By eliminating the annual fee for the TEAD license, the Army will save approximately \$18,000 on the next payment. We will also gain indirect cost savings by reducing the labor to manage the TEAD license, including renewal and amendment submittals. We see no disadvantages to the consolidation.
3. We recommend the following actions: TEAD requests termination of the SUC1391 license from NRC Region IV; concurrently, JMC requests consolidation of the two licenses from NRC Region III. Per our conversation with NRC Region IV, they indicated support of license consolidation.


We request the Nuclear Regulatory Commission consolidate license number SUB-1391 issued to Tooele Army Depot (TEAD) into license number SUC-1380 issued to the US Army Joint Munitions command (JMC). This action will terminate the SUB-1391 license and the SUC-1380 license would assume responsibility for licensed material and operations at TEAD. We have enclosed a memorandum from TEAD to JMC requesting consolidation of the licenses.

The SUC-1391 license and the SUC-1380 license are both Army licenses covering depleted uranium ammunition items and both authorize the same storage, handling, and logistic operations. The SUC-1380 license currently lists TEAD as a bulk storage installation.

We view the license consolidation as a positive action as it will reduce the total number of Army licenses by one, reduce the amount of annual license fees paid by the Army, and eliminate the current redundancy between the two licenses.

The SUC-1380 license will continue to identify Mr. Kelly Crooks as the radiation safety officer and Mr. Gary Buckrop as the alternate radiation safety officer. There are no changes in radiation safety personnel at TEAD.
