




Web-based ADAMS (WBA)



- WBA – debut in October 2010
- Two libraries in WBA:
 - Public Library
 - Public Legacy Library

Public Library (PARS)

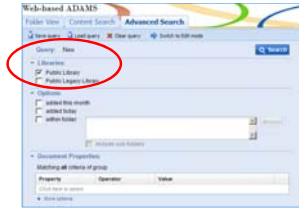


- WBA's Public Library (or "Publicly Available Records System") (PARS) refers to the library within ADAMS that provides full-text documents in PDF format

Public Library (PARS)



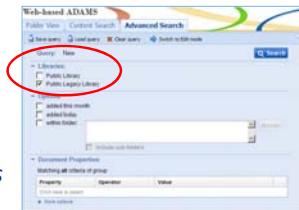
- WBA's Public Library refers to the library within ADAMS that provides access to documents that are **mostly** dated November 1999 to present



Public Legacy Library



- WBA's Public Legacy Library refers to the library within ADAMS that provides *bibliographic records* for NRC documents

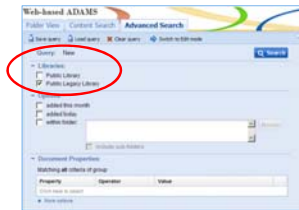


- Electronic full-text is not available*

Public Legacy Library



- The documents in WBA's Public Legacy Library predate November 1999 and are likely available on microfiche in the Public Document Room (PDR)

Use of AND – OR – NOT in a search strategy



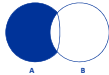

• OR

– 05000325 OR 0500024

• NOT

– creek NOT creak

• NESTING

– (pge AND gas) NOT pacific
