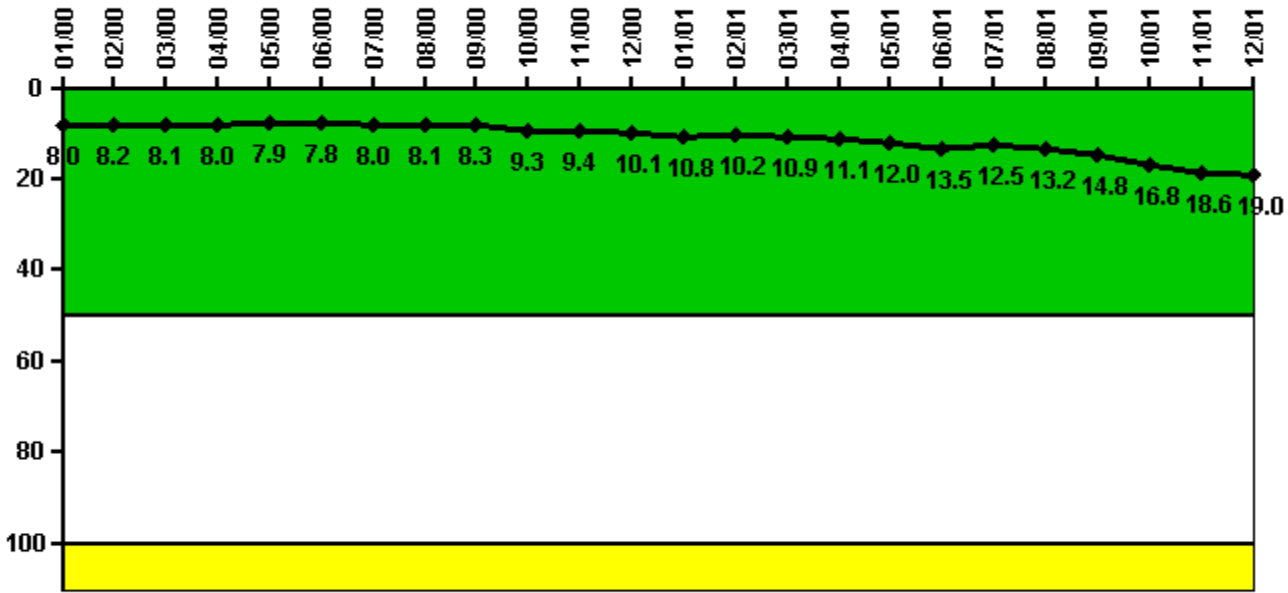

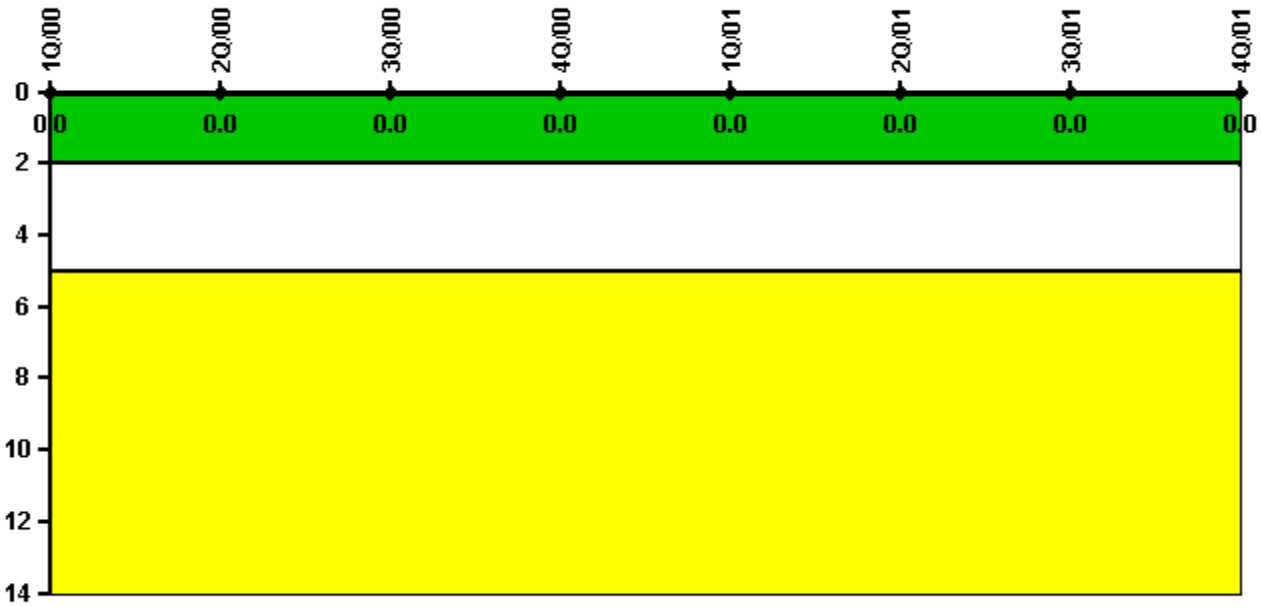

Occupational Exposure Control Effectiveness



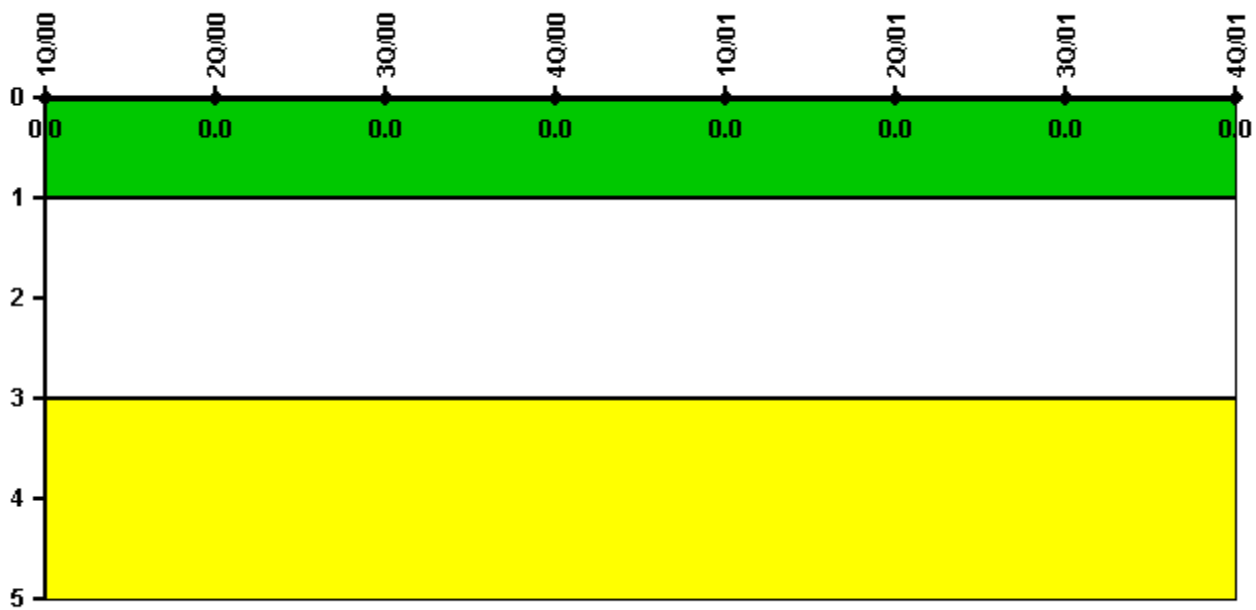

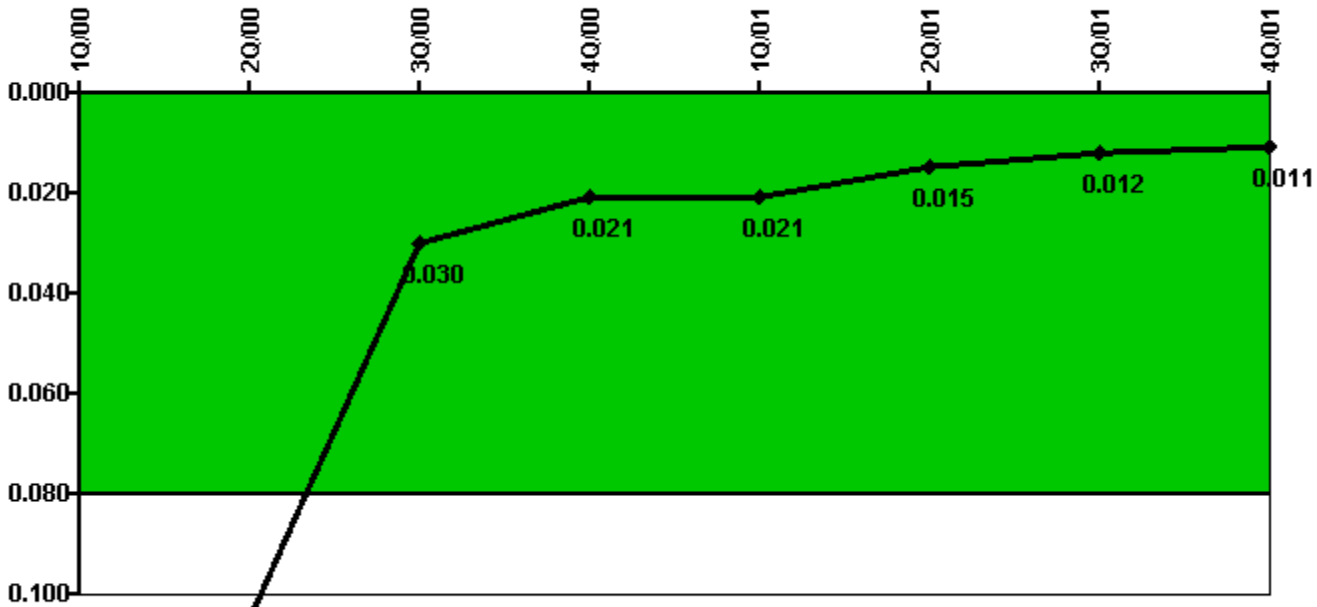
