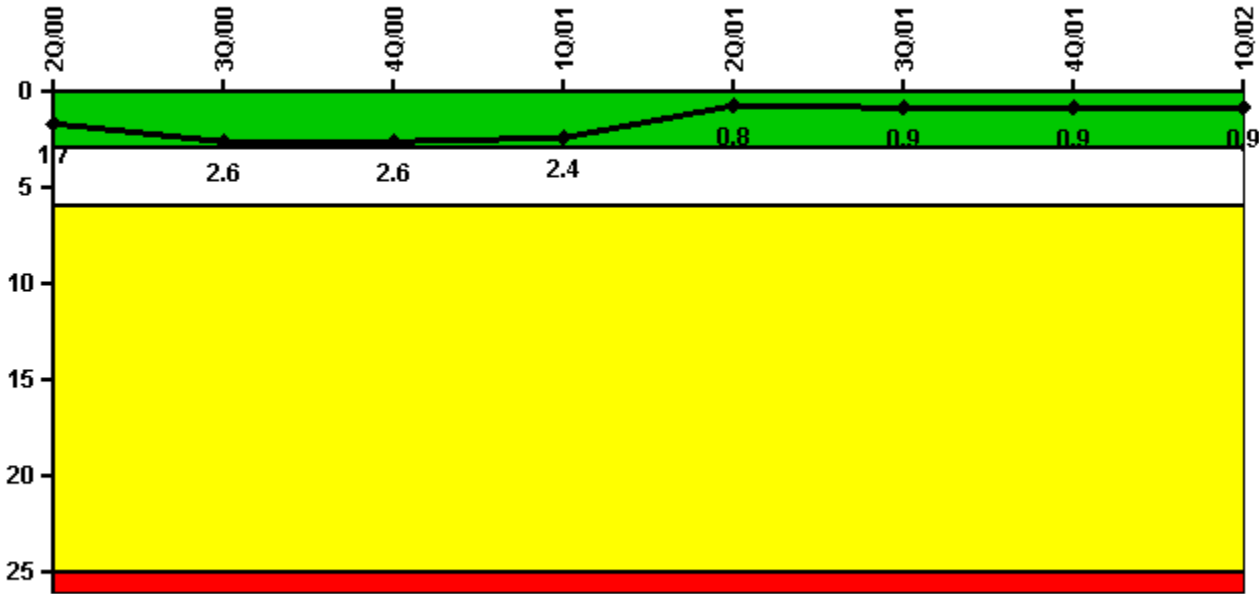

Unplanned Scrams per 7000 Critical Hrs



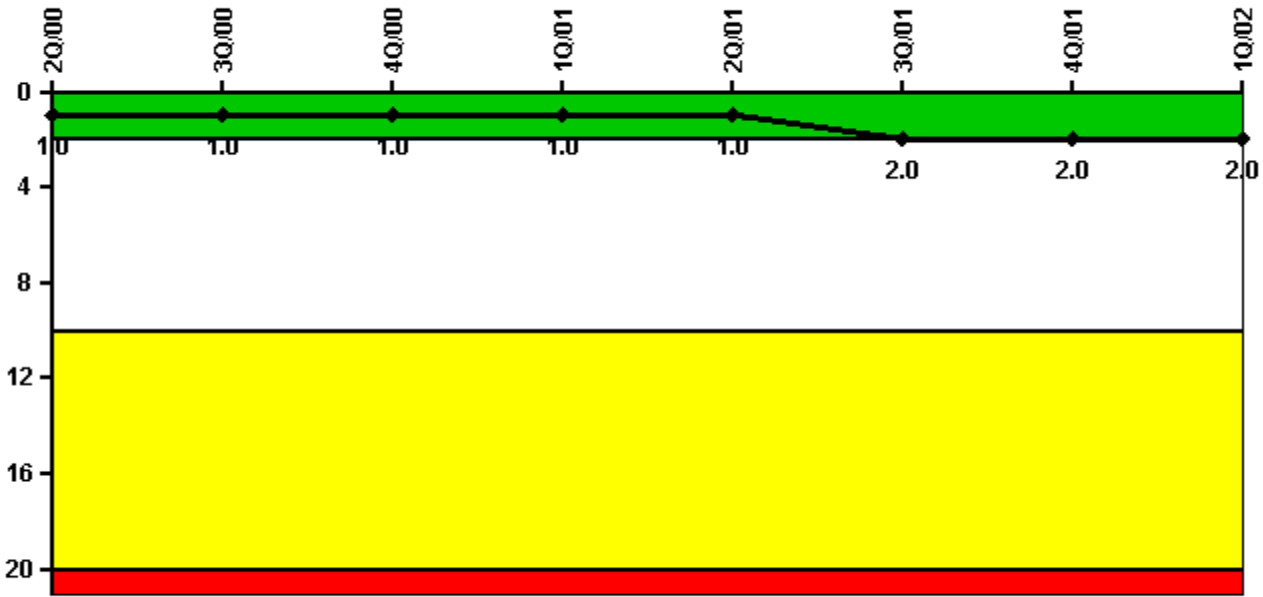

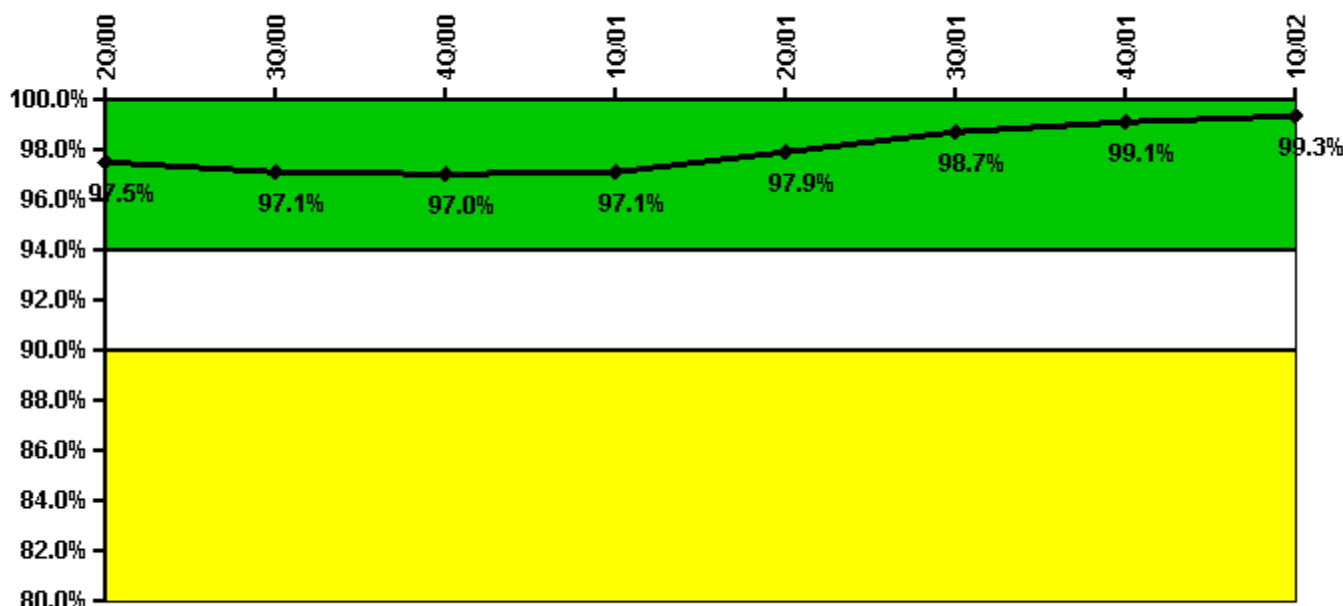

1Q/02: A revision has been made to previously submitted data for the Alert and Notification System (ANS) Reliability indicator. It was determined there was one day each month where both a full test and a silent test of ANS sirens was performed; however, only one of these tests had been reported. The data for the first through fourth quarters in 2001 was affected and has been revised (1Q2001, 2Q2001, 3Q2001 and 4Q2001). The change to the data does not affect the color of the indicator.

Occupational Exposure Control Effectiveness



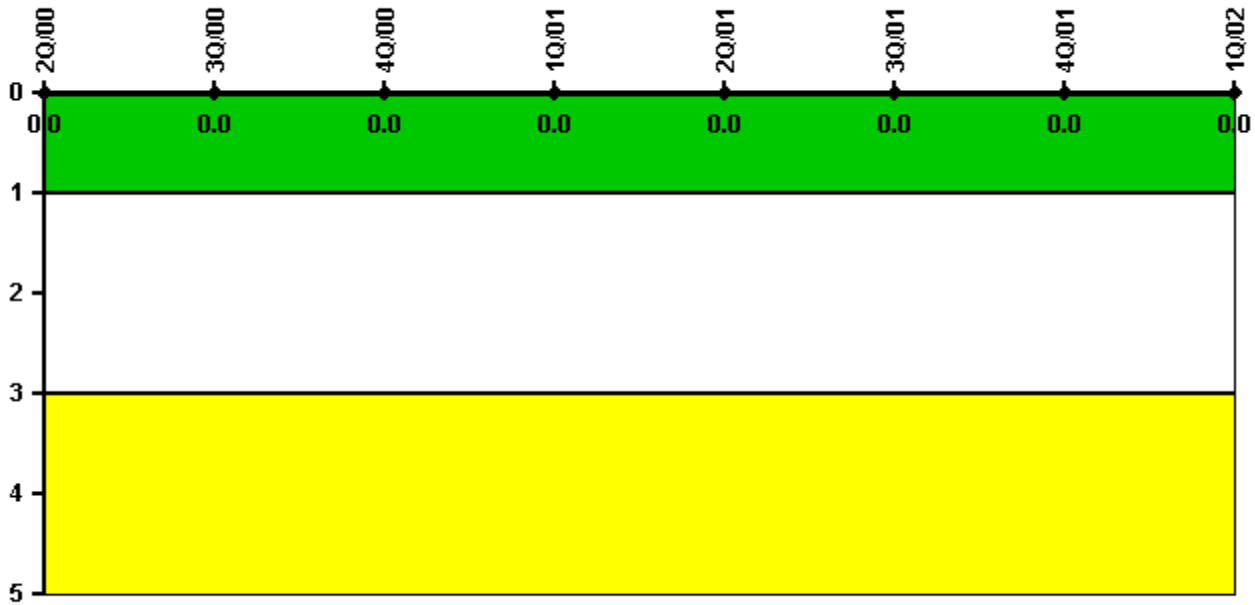
