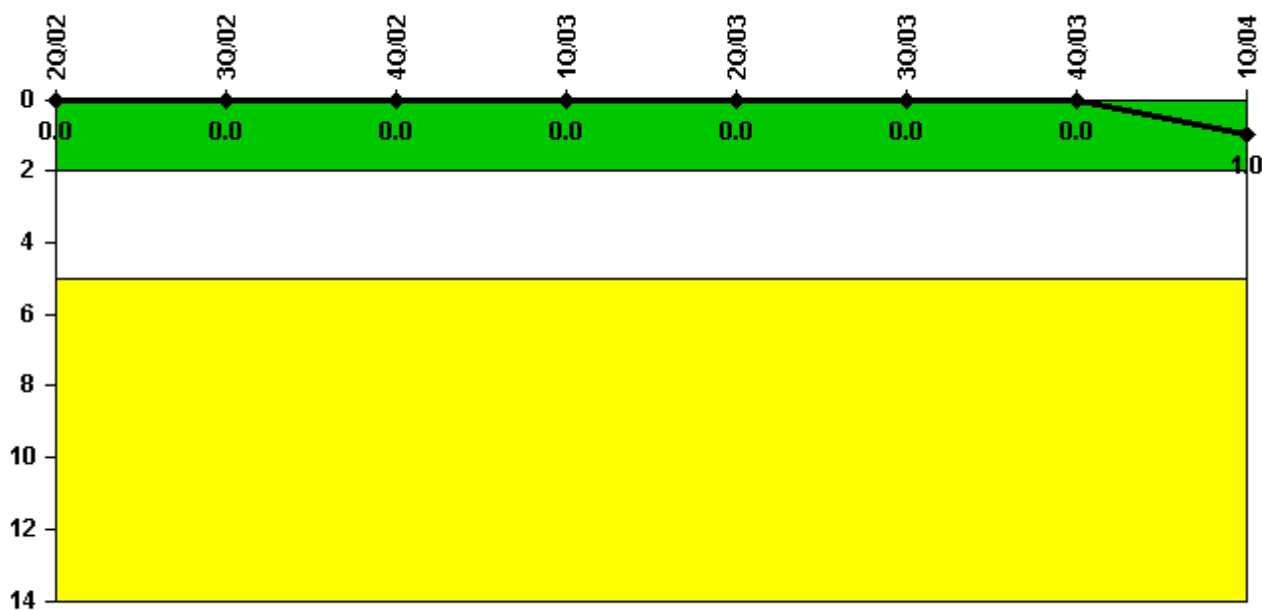

Occupational Exposure Control Effectiveness



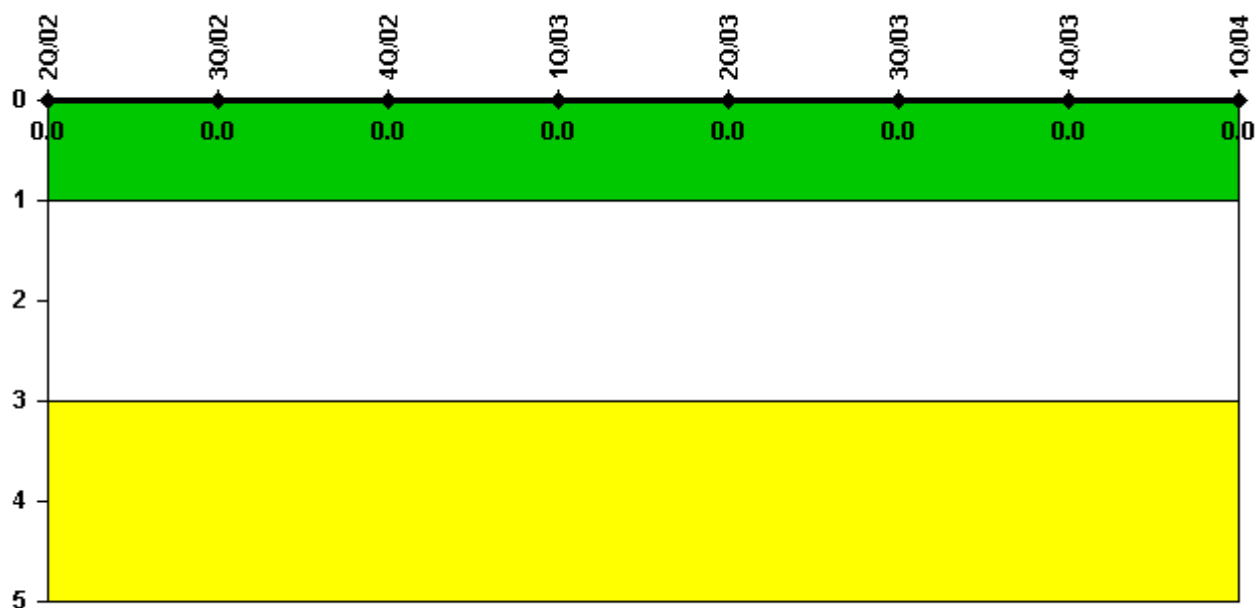
