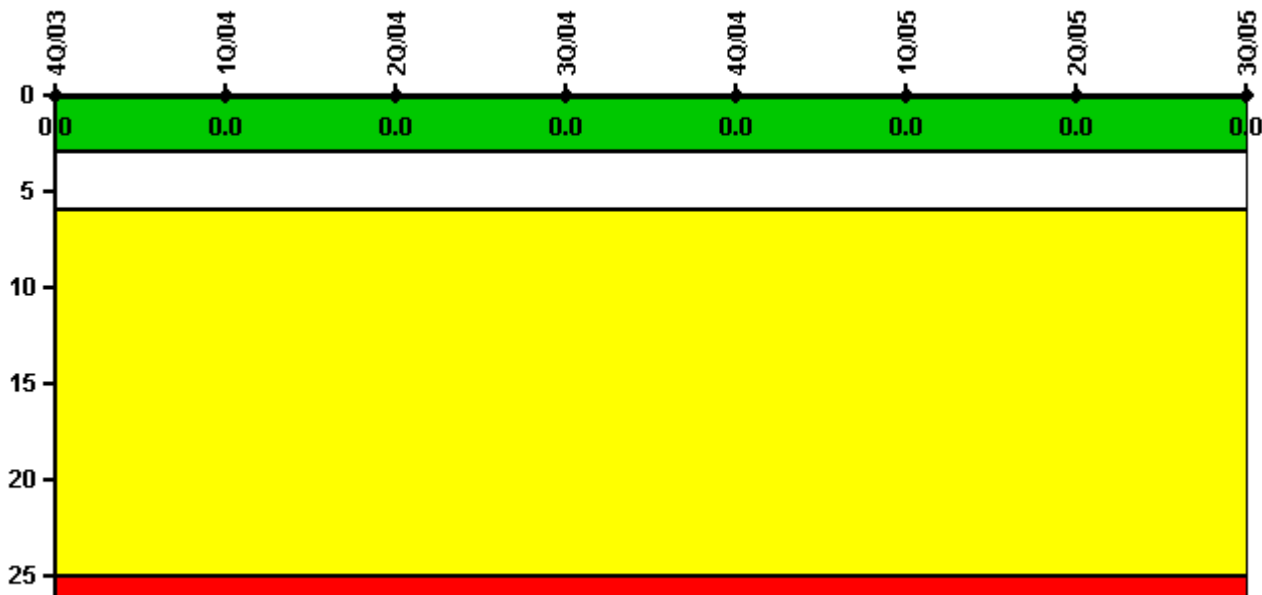

Unplanned Scrams per 7000 Critical Hrs



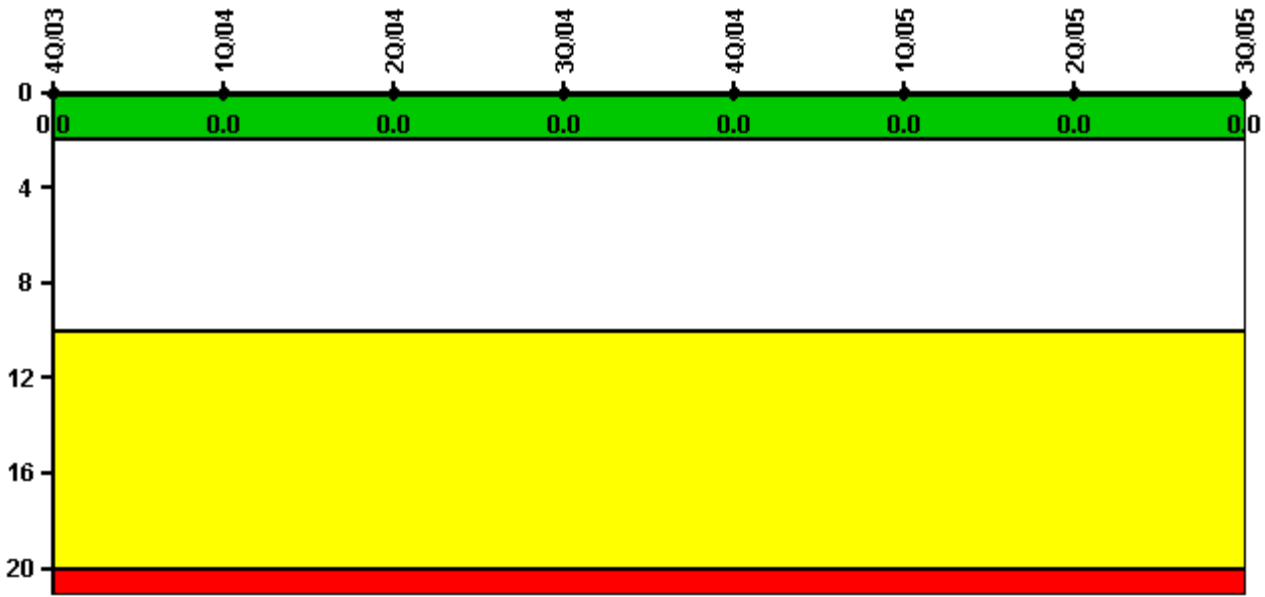

Scrams with Loss of Normal Heat Removal



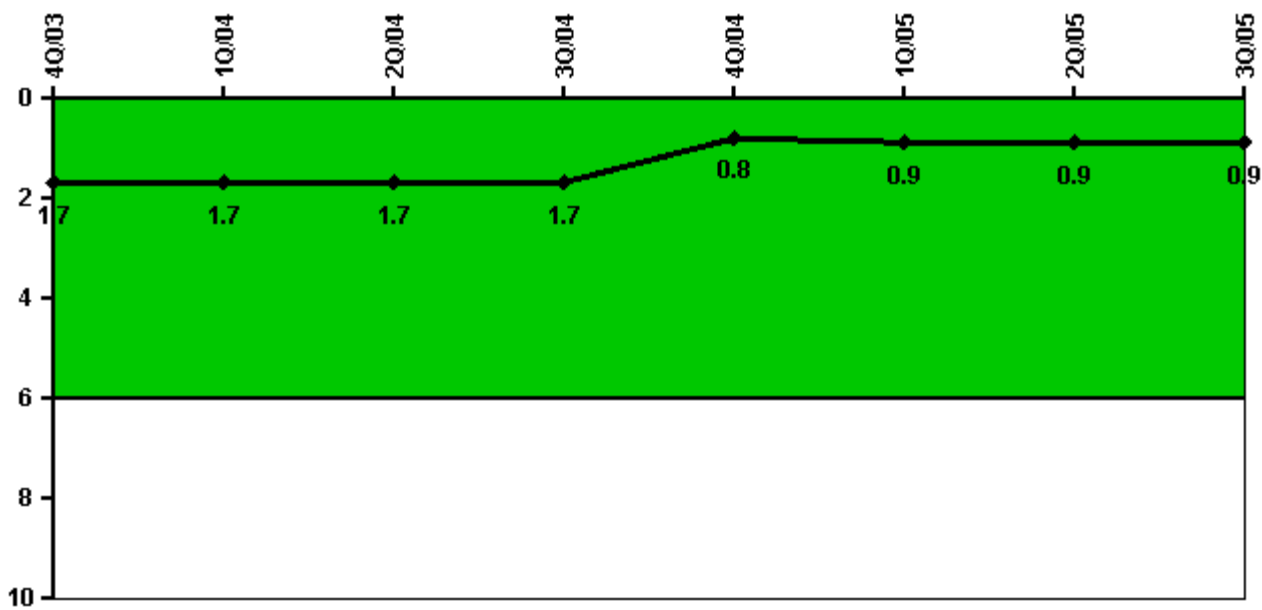

Unplanned Power Changes per 7000 Critical Hrs



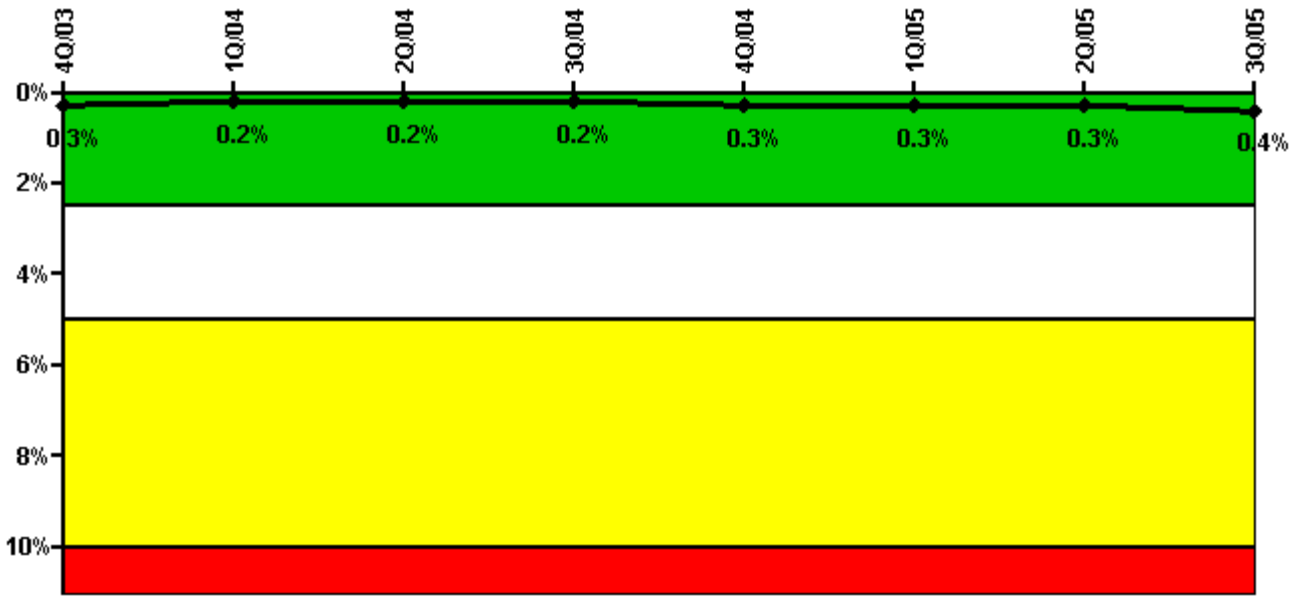

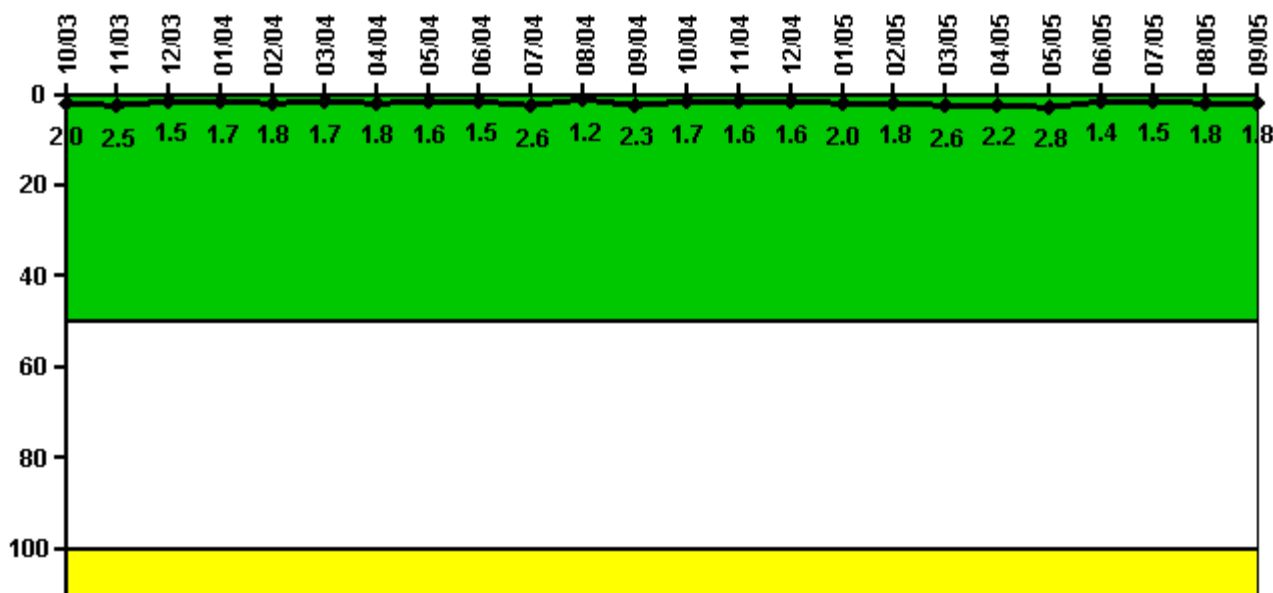

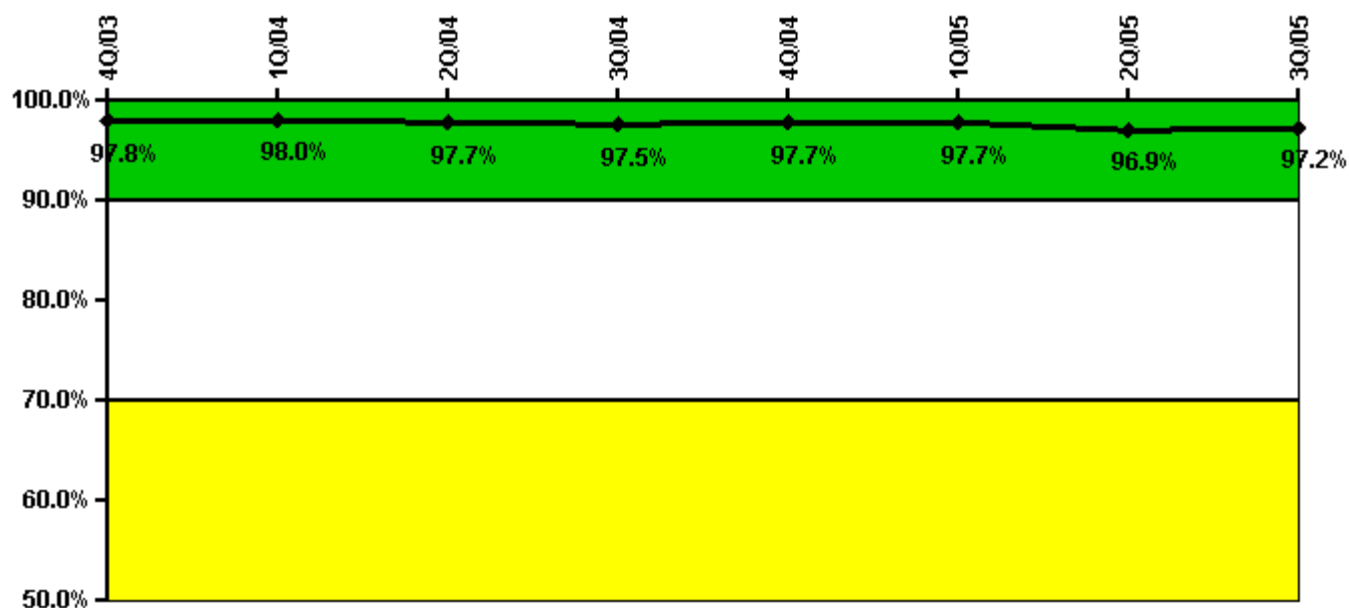

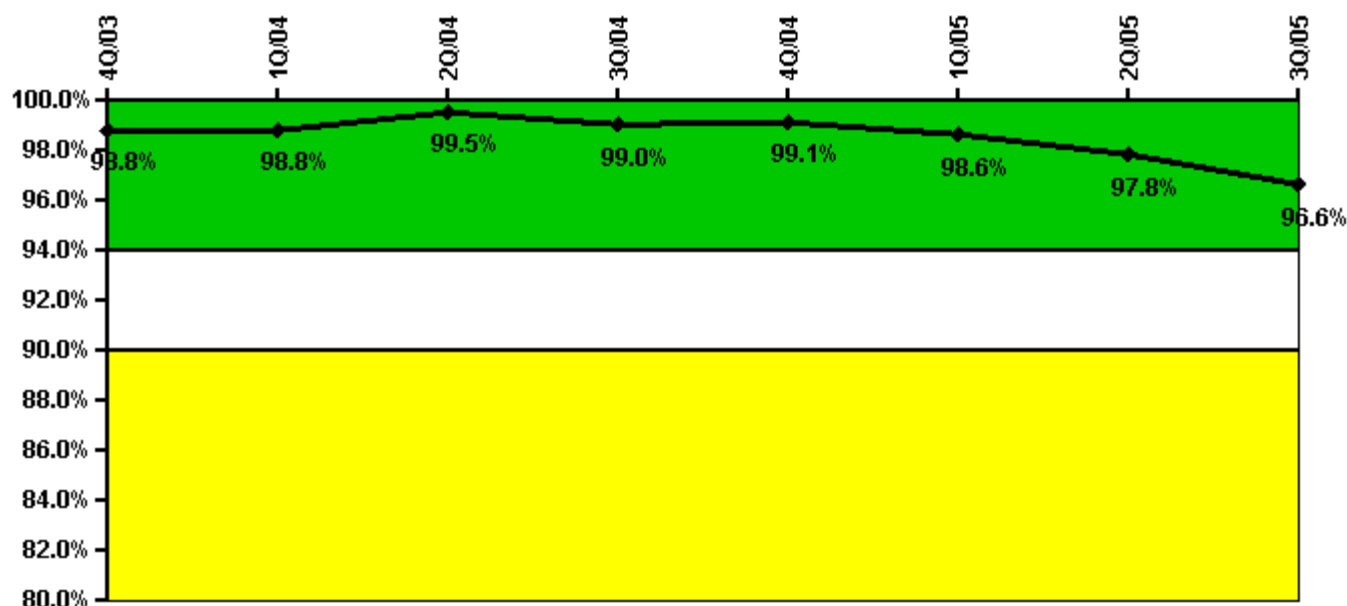

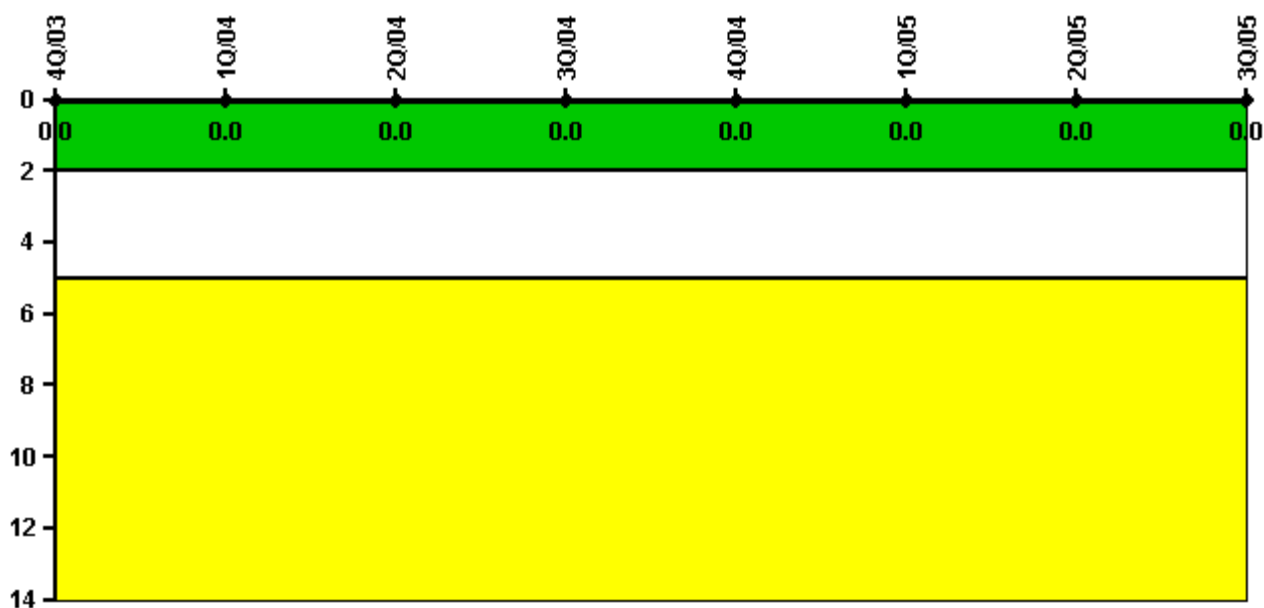

2Q/05: Siren testing for ANO is initiated by the Arkansas Department of Health (ADH). For the month of April, 2005, the ADH originally reported 5 siren failures due to an encoder malfunction. During a recent Alert Notification System assessment, it was identified that only 1 of the 5 sirens was actually scheduled for testing during the encoder failure. Each of the other 4 sirens were already scheduled for later in the month and, in fact, passed their scheduled tests. The number of successful siren tests for April 2005 has been revised from 44 to 48.

Occupational Exposure Control Effectiveness



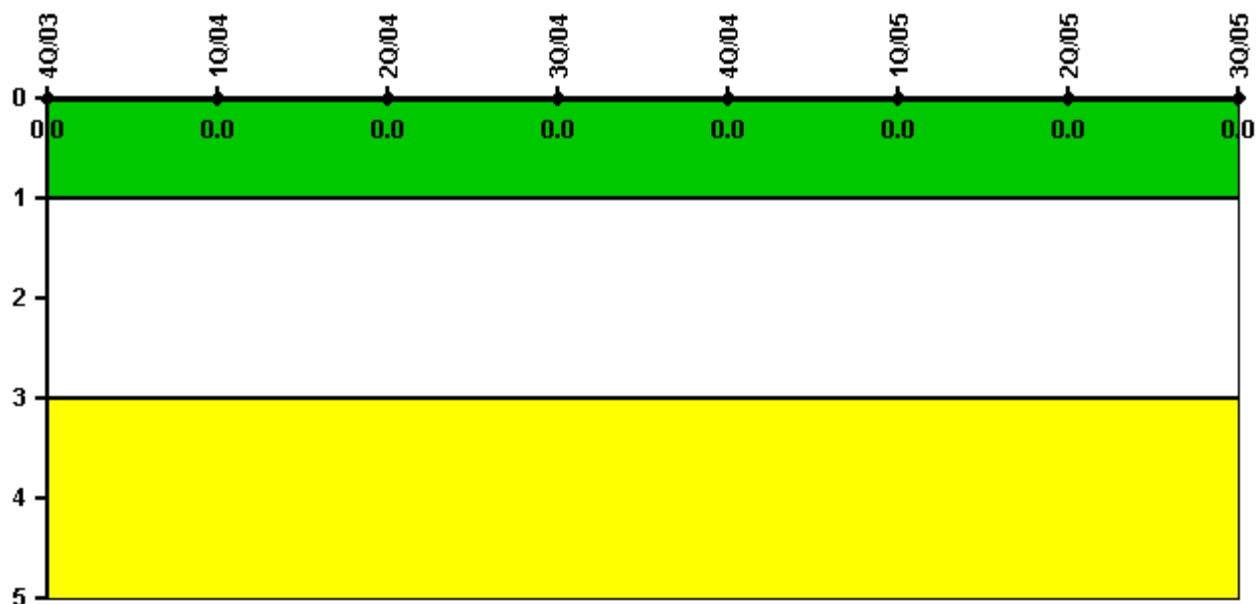
