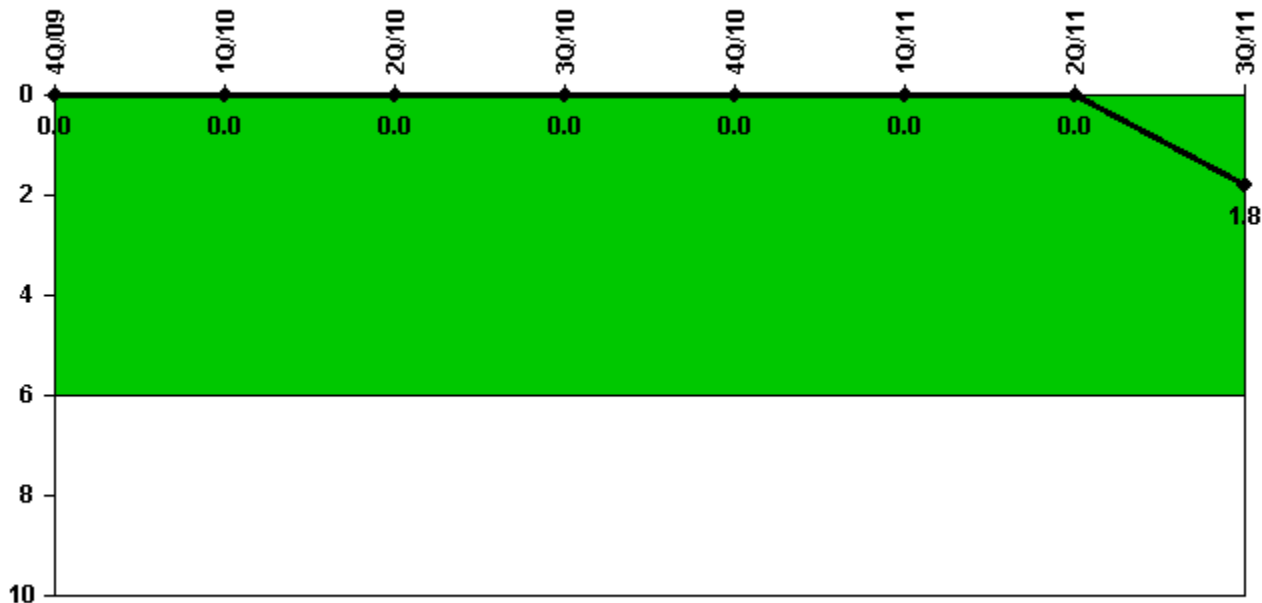

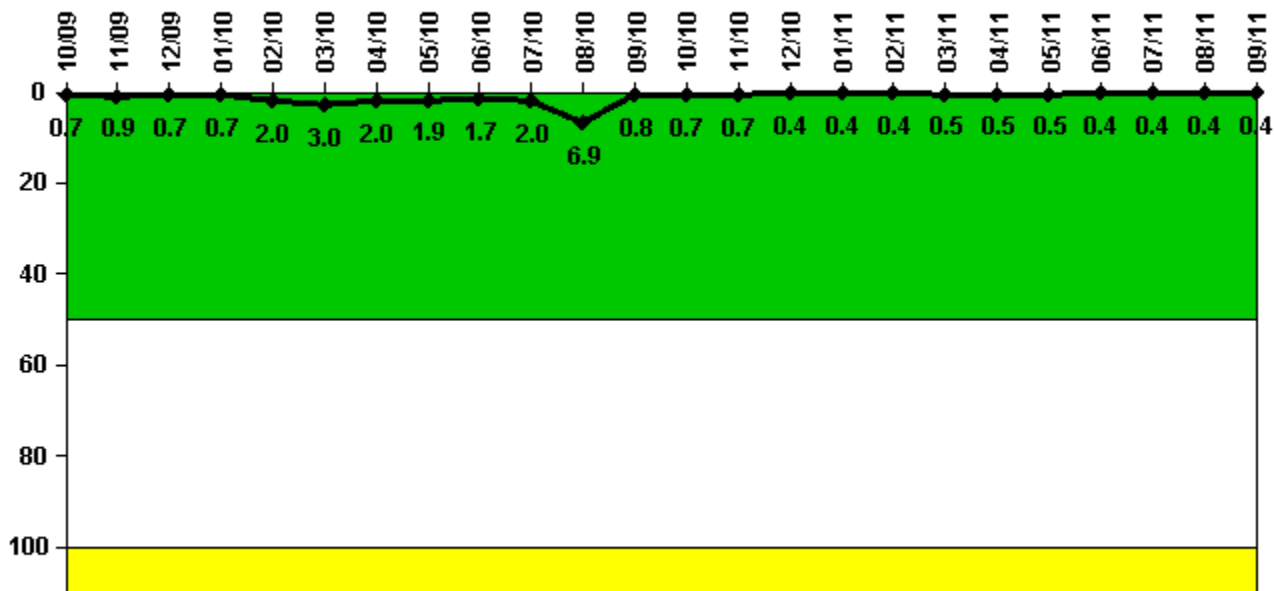

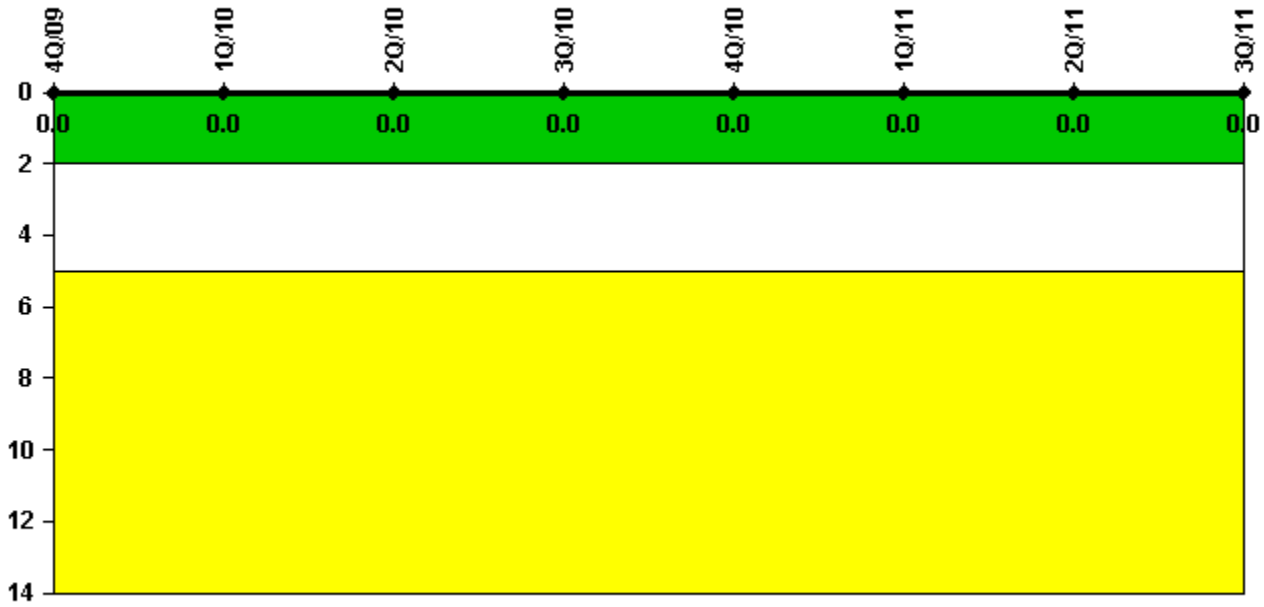

Occupational Exposure Control Effectiveness



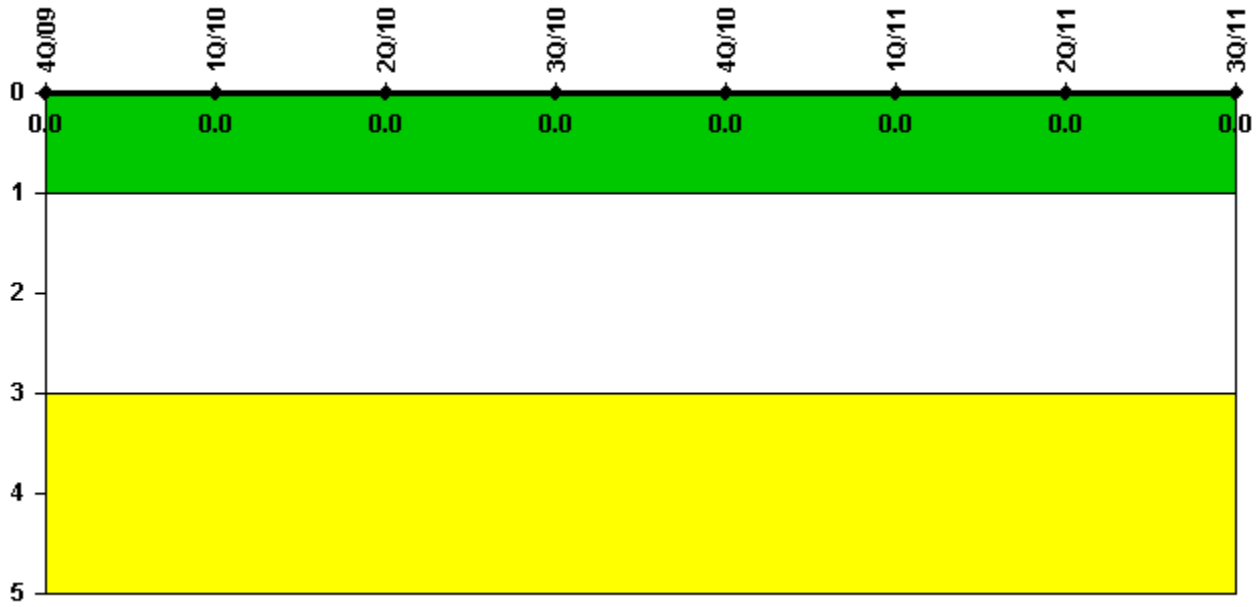
