

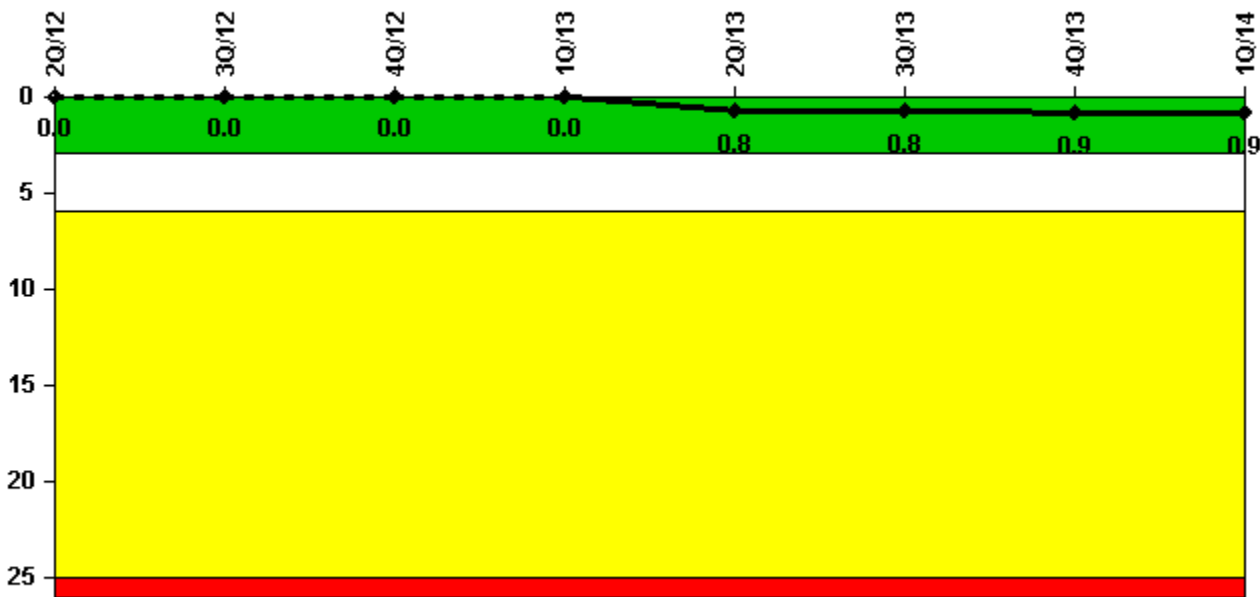

In addition, the High Pressure Injection System was updated from Q2 2012 to the end of Q3 2013 due the PRA value being incorrect. None of these changes resulted in a color change.

Unplanned Scrams per 7000 Critical Hrs



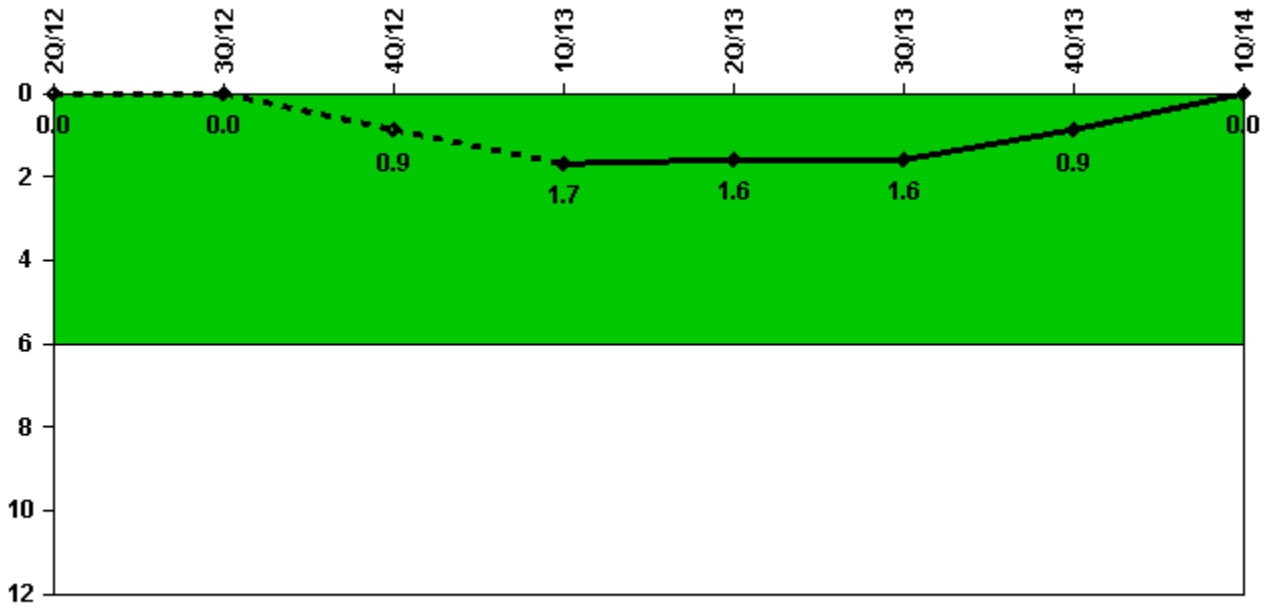

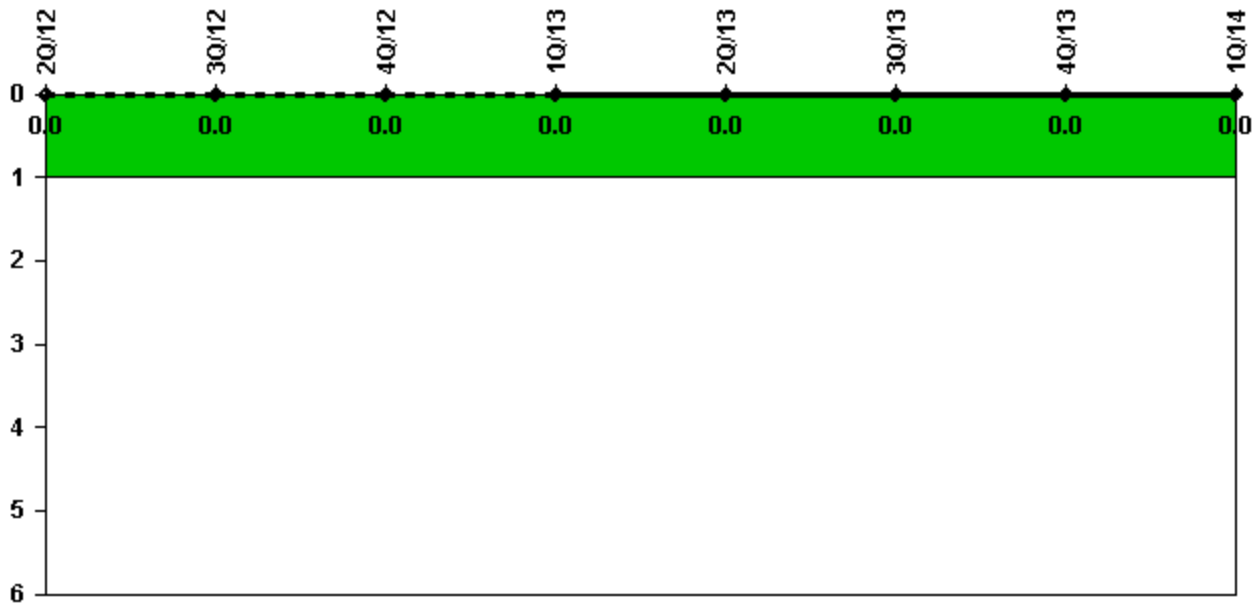

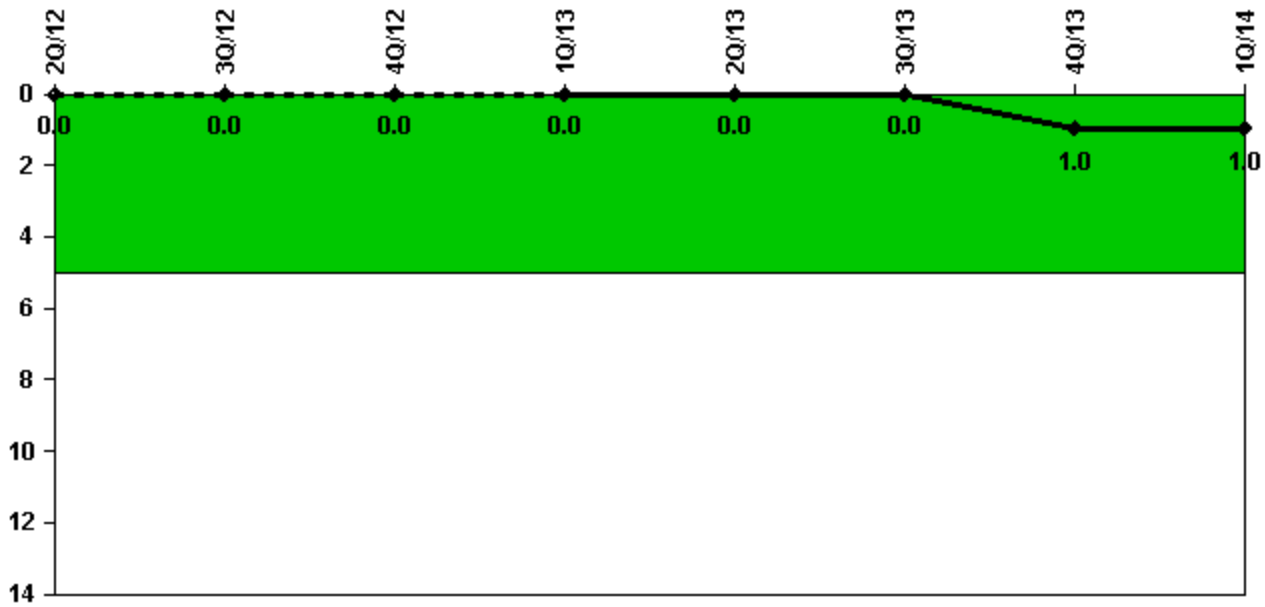

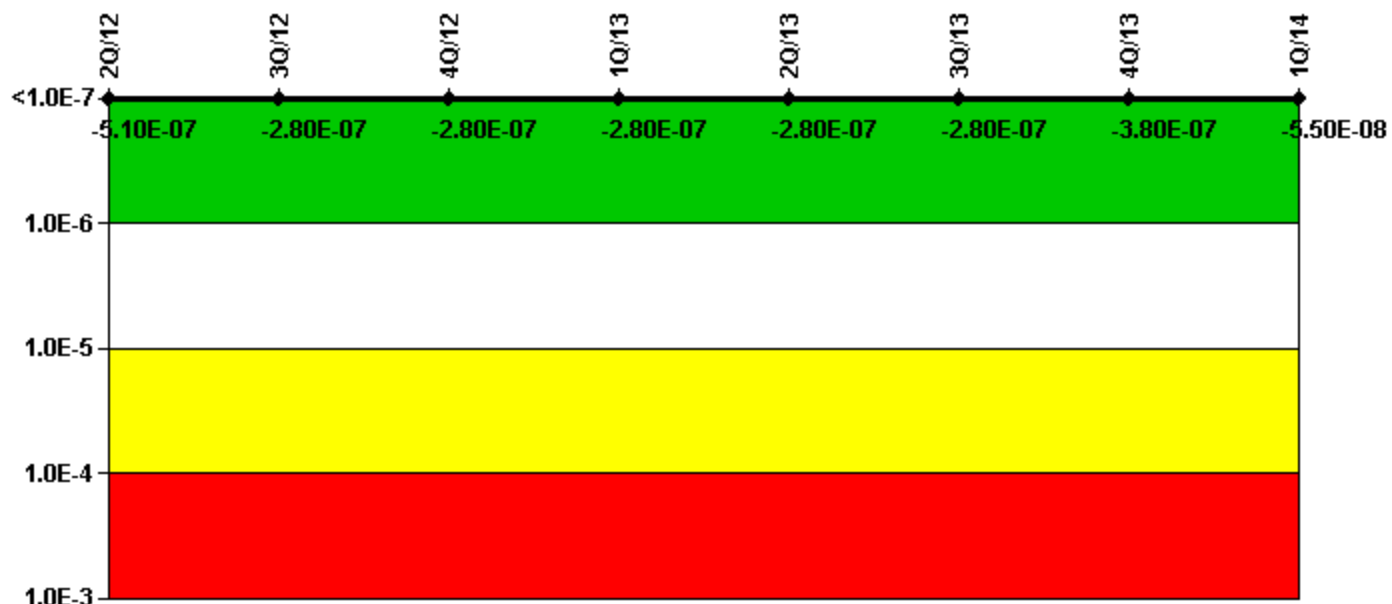

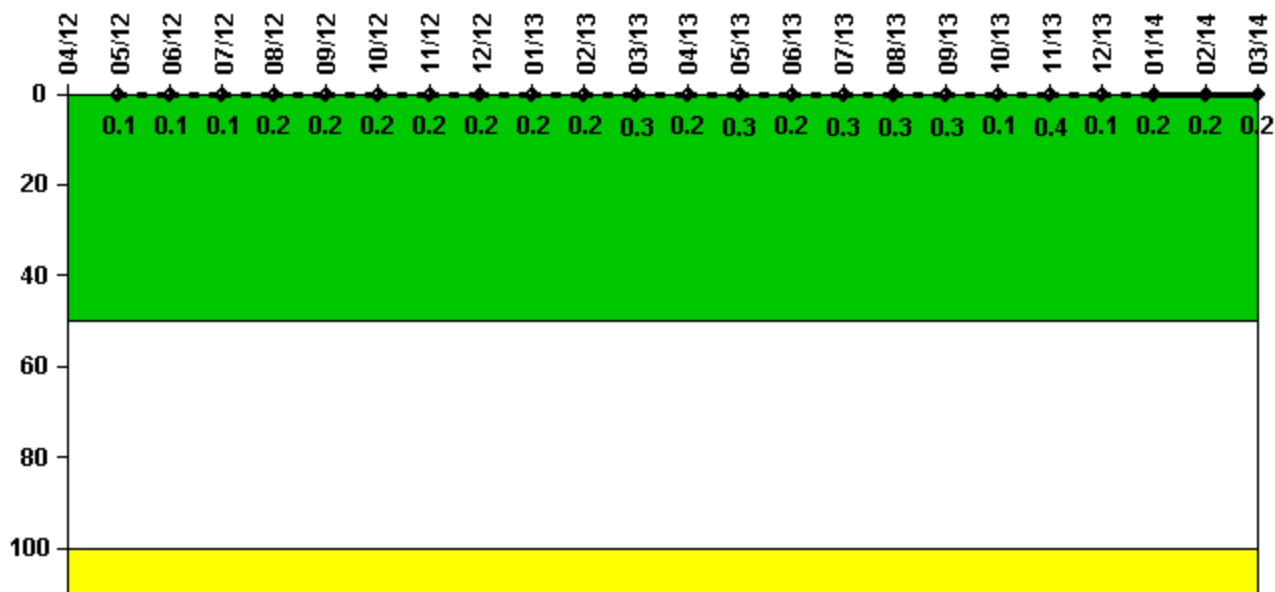

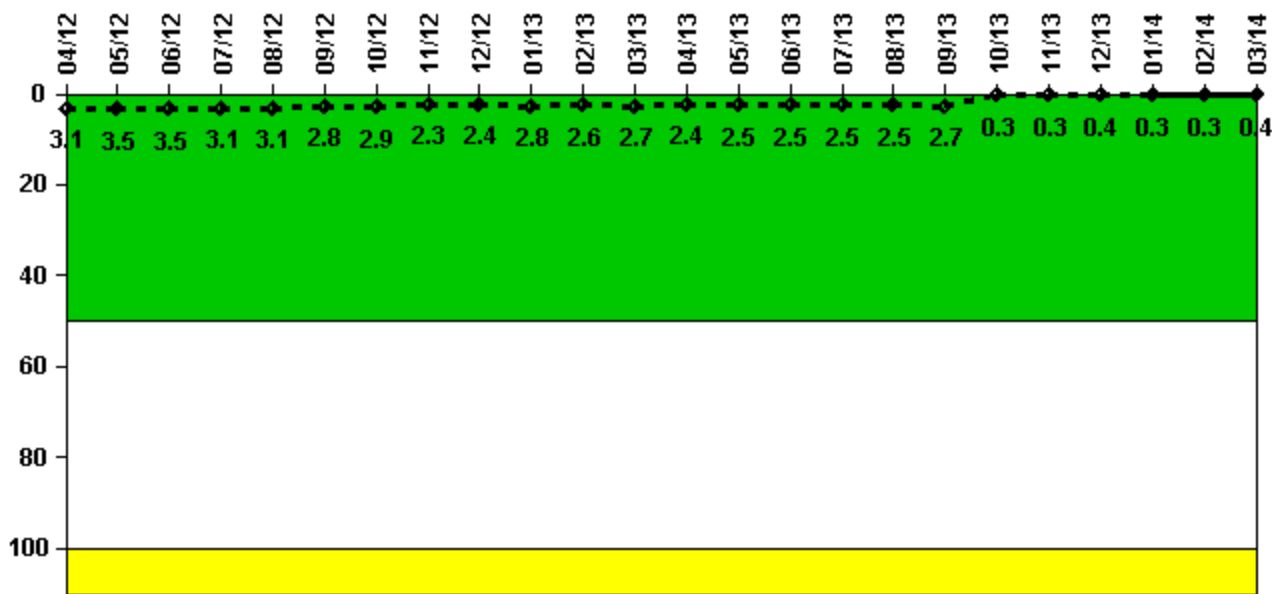

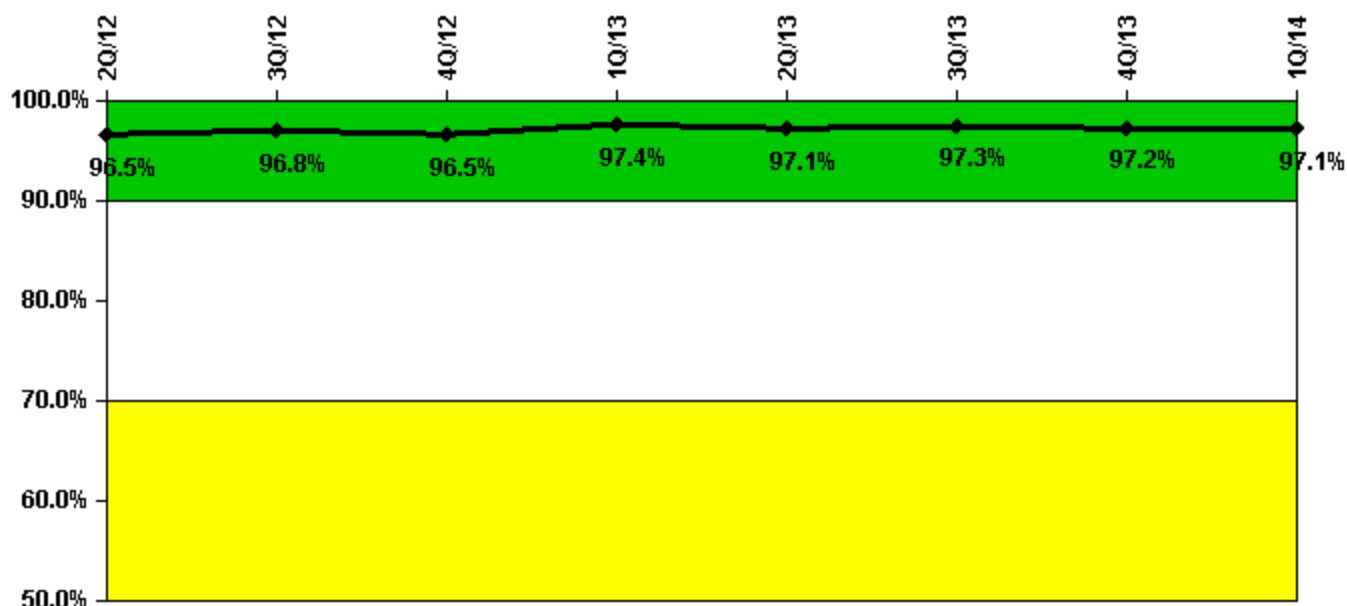

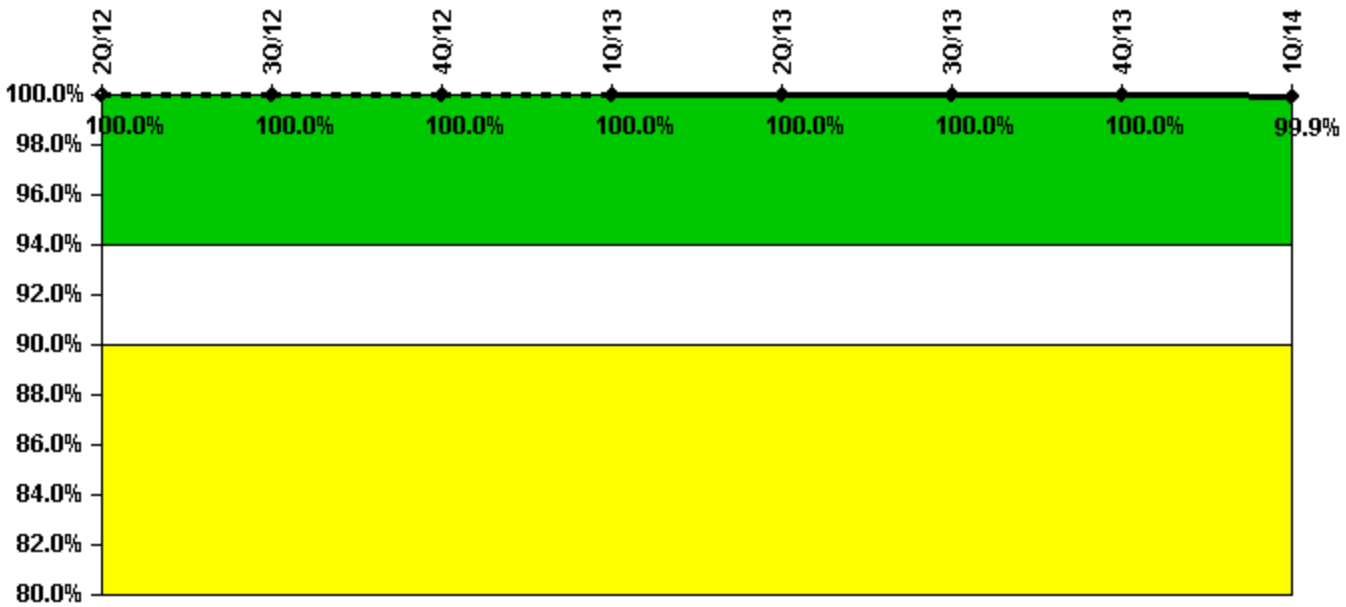

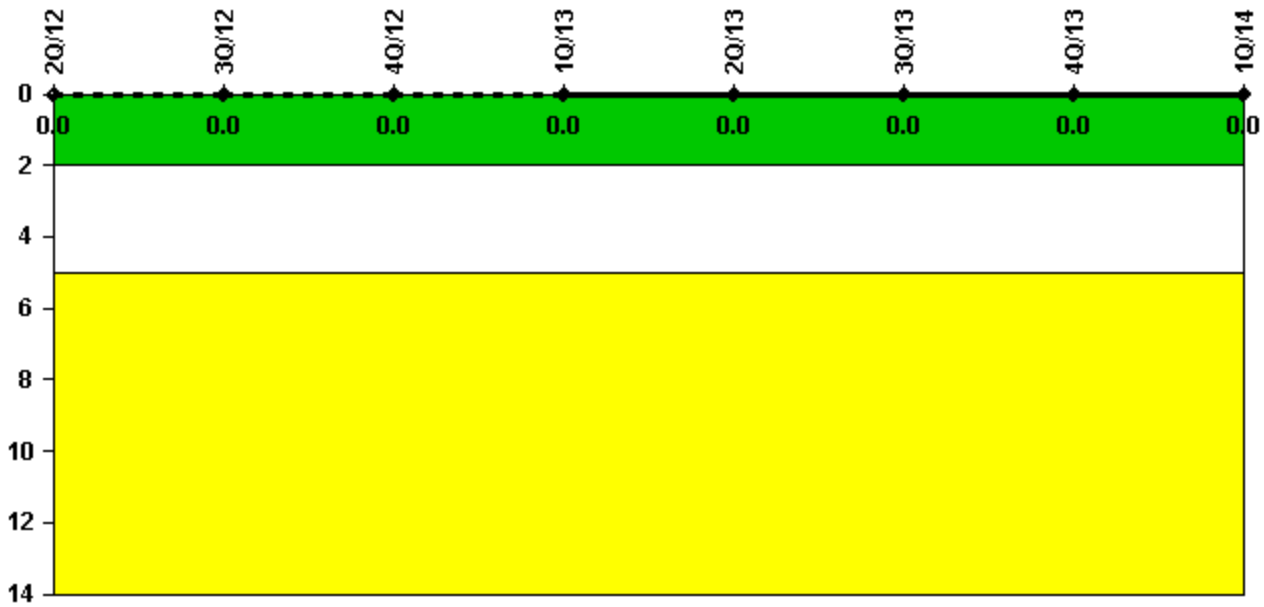

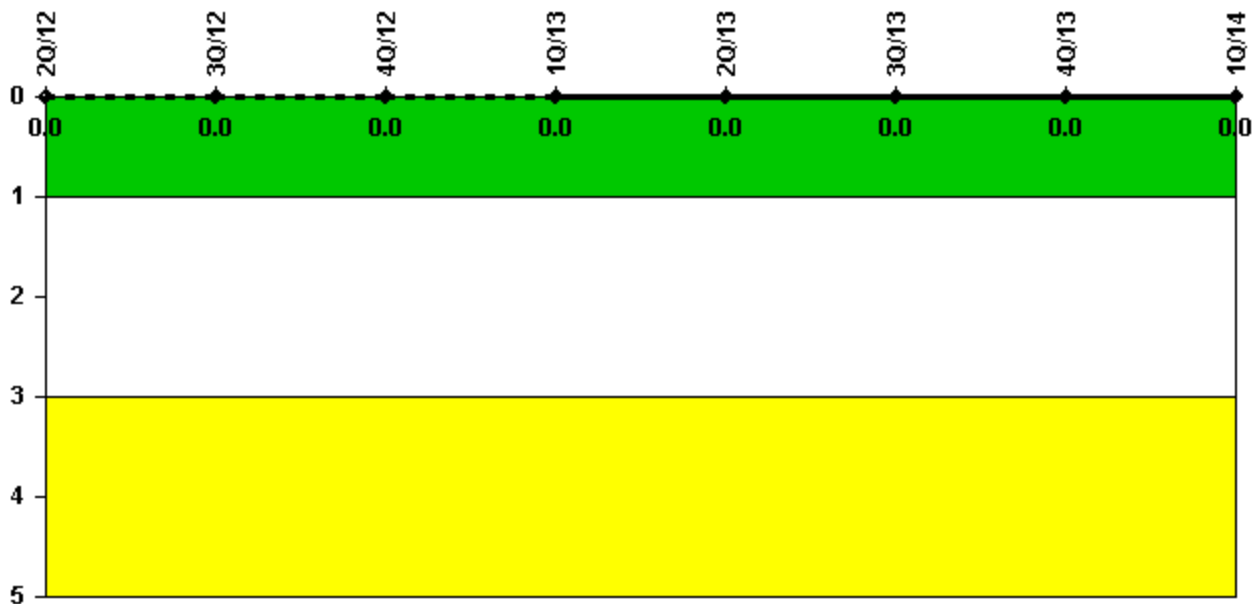
