

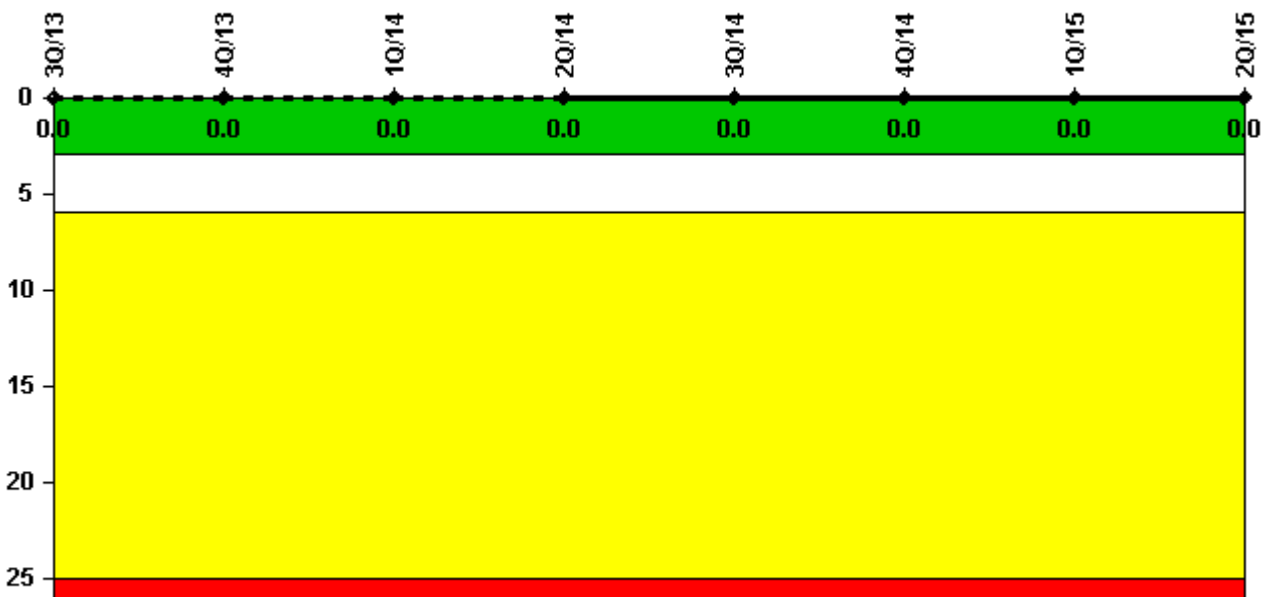

Unplanned Scrams per 7000 Critical Hrs



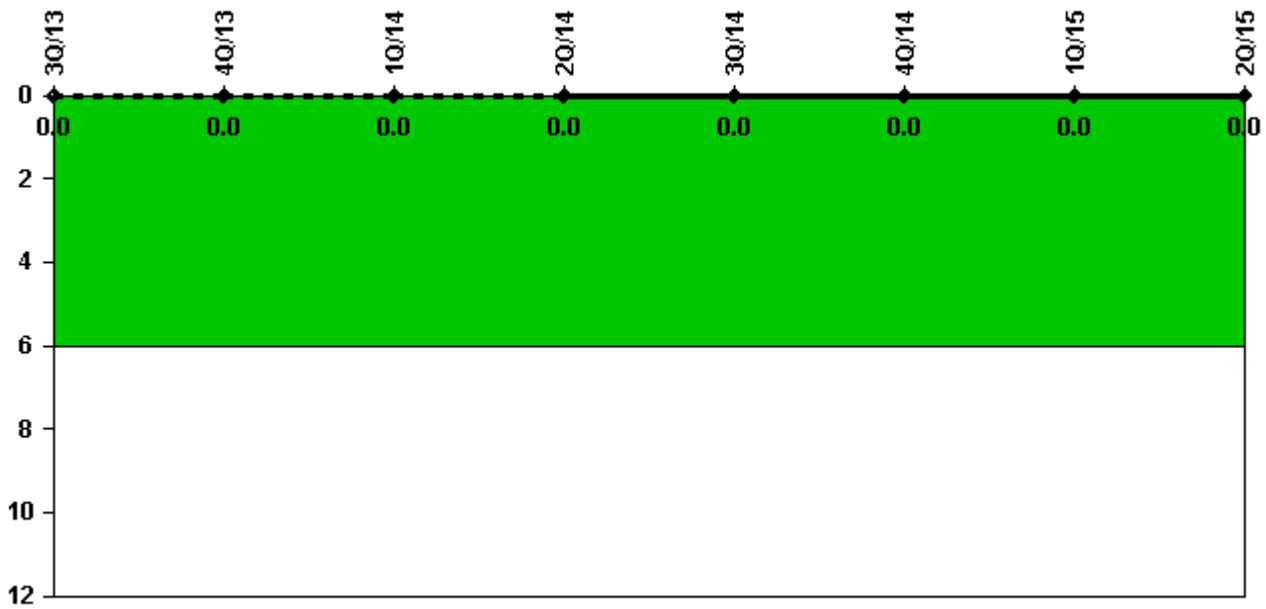

Unplanned Power Changes per 7000 Critical Hrs



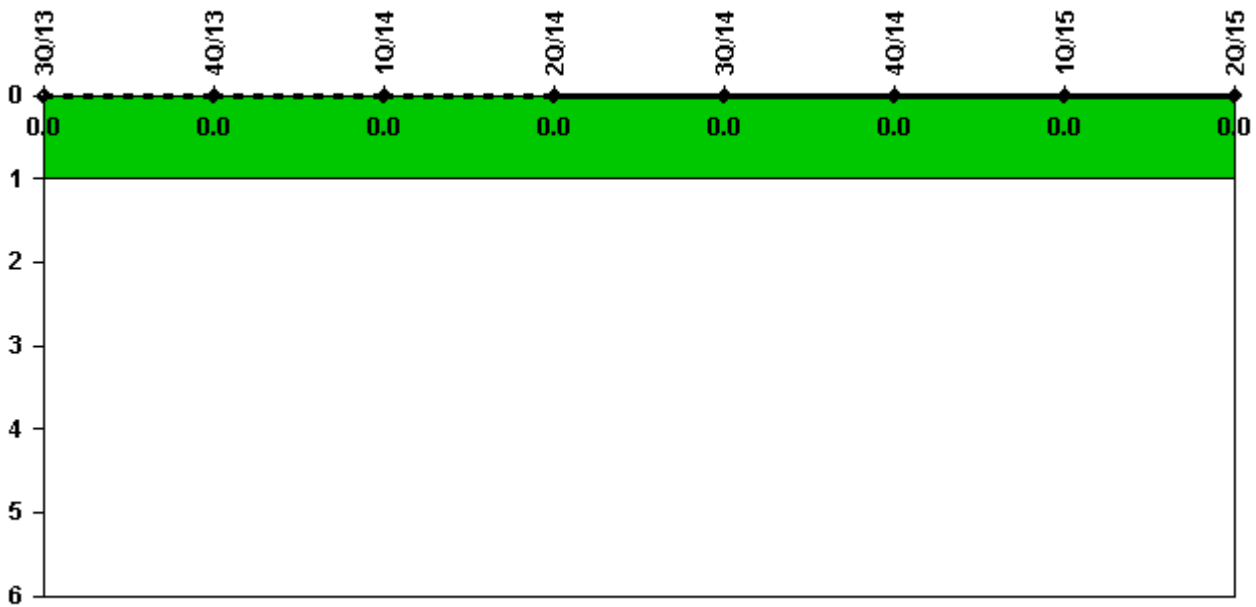

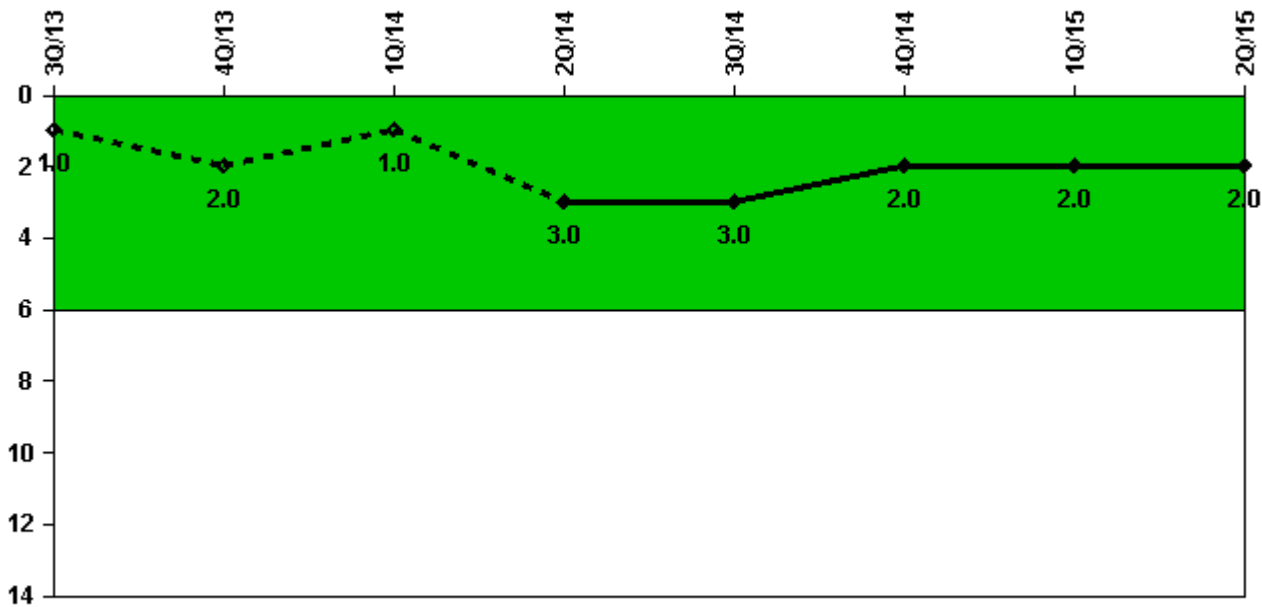

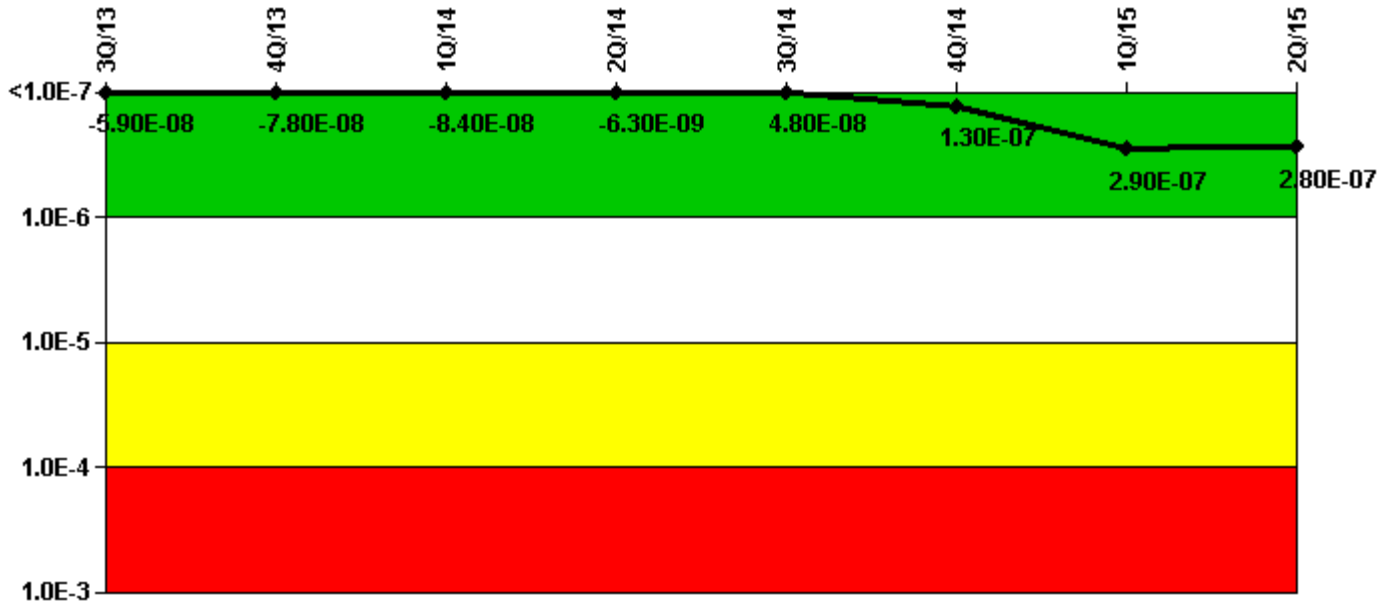
2Q/15: LER 1-2015-001, dated 4/10/15, reported one event where the failure of the associated Auxiliary Oil pump for the HPCI system rendered the system inoperable and was considered a SSFF. LER 1-2015-002, dated 5/20/15, reported one event where DG3 and DG4 were simultaneously inoperable and considered a SSFF for the onsite standby AC power source. LER 1-2015-002 counted for both Unit 1 and Unit 2.

2Q/14: LER 1-2014-003, dated 5/19/14 reported two events where simultaneous opening of the secondary containment airlock doors resulted in a SSFF. Additionally, a SSFF reported in November 2013 was removed based on the retraction of LER 1-2013-003 by letter dated 6/13/14. A change file was created in June 2014. These changes did not affect the "color" of the indicator.

2Q/14: LER 1-2014-003, dated 5/19/14 reported two events where simultaneous opening of the secondary containment airlock doors resulted in a SSFF. 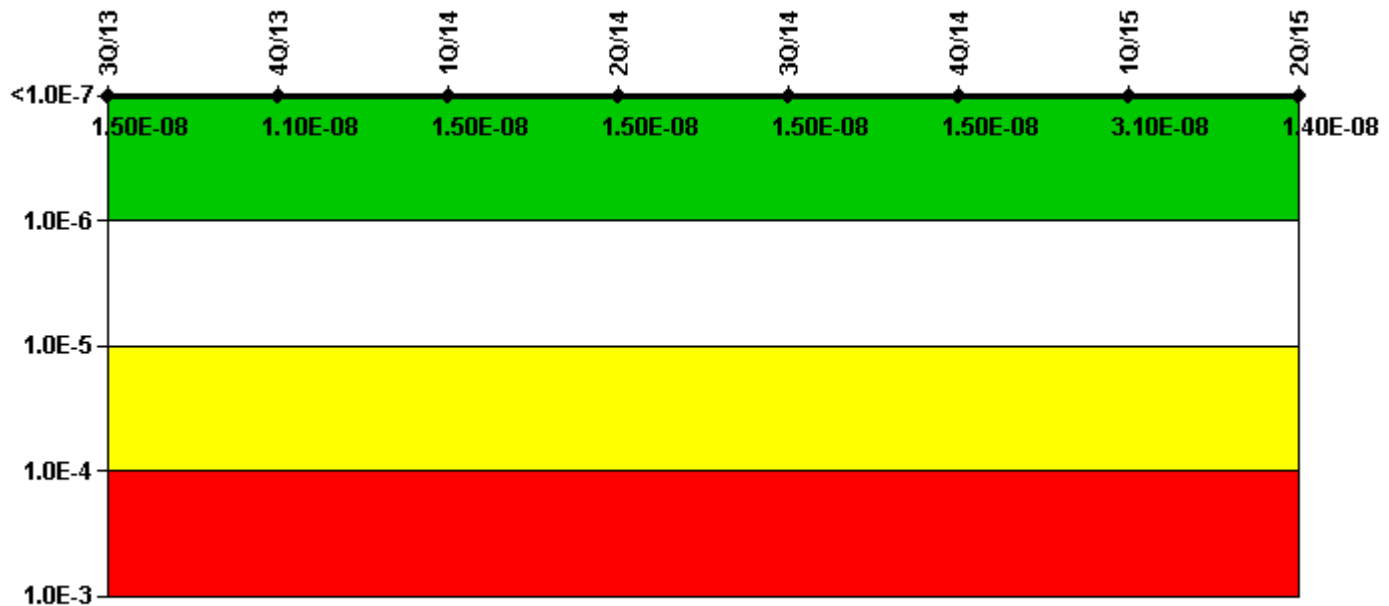

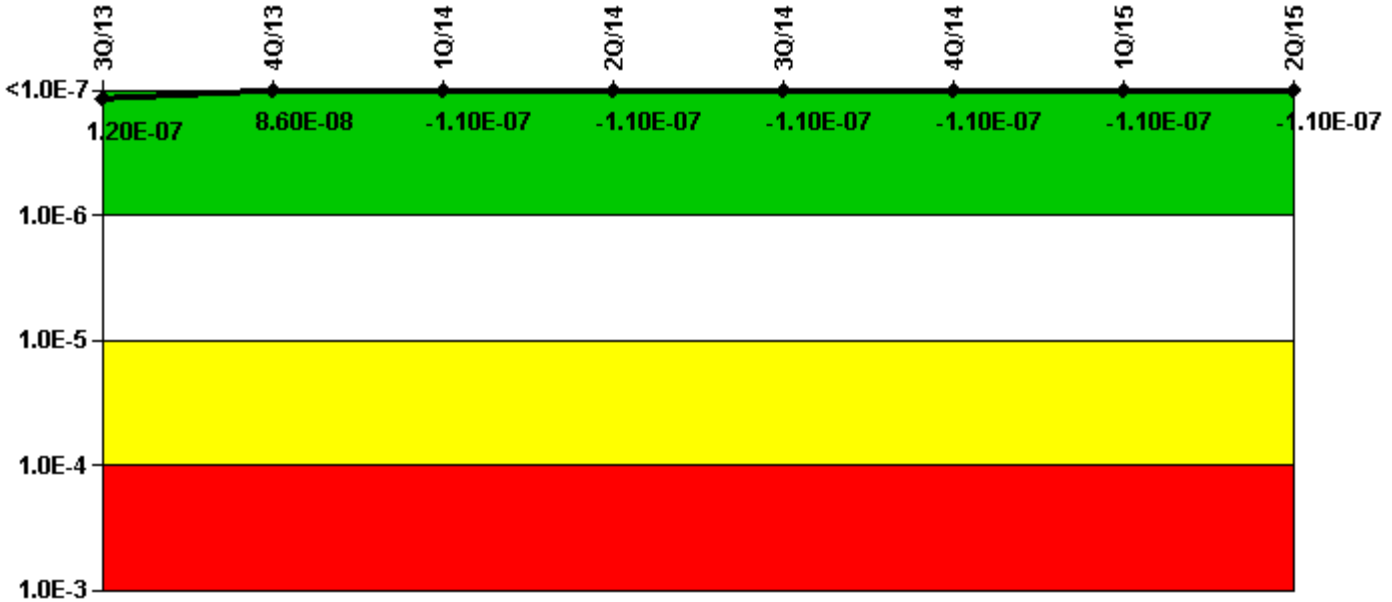

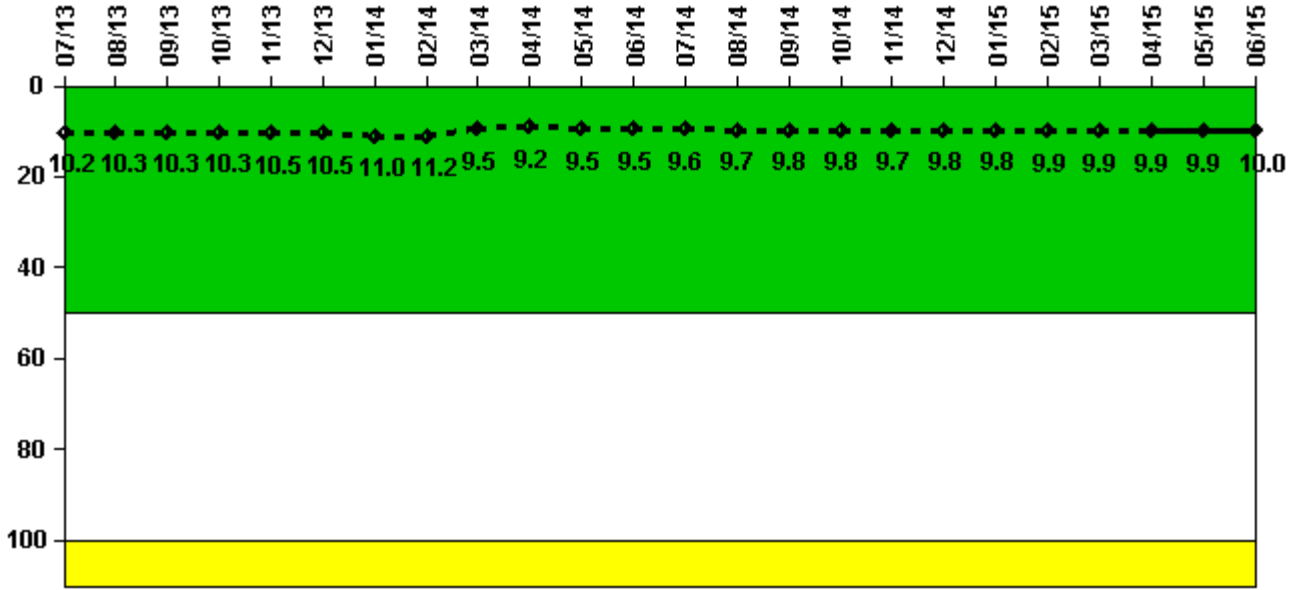

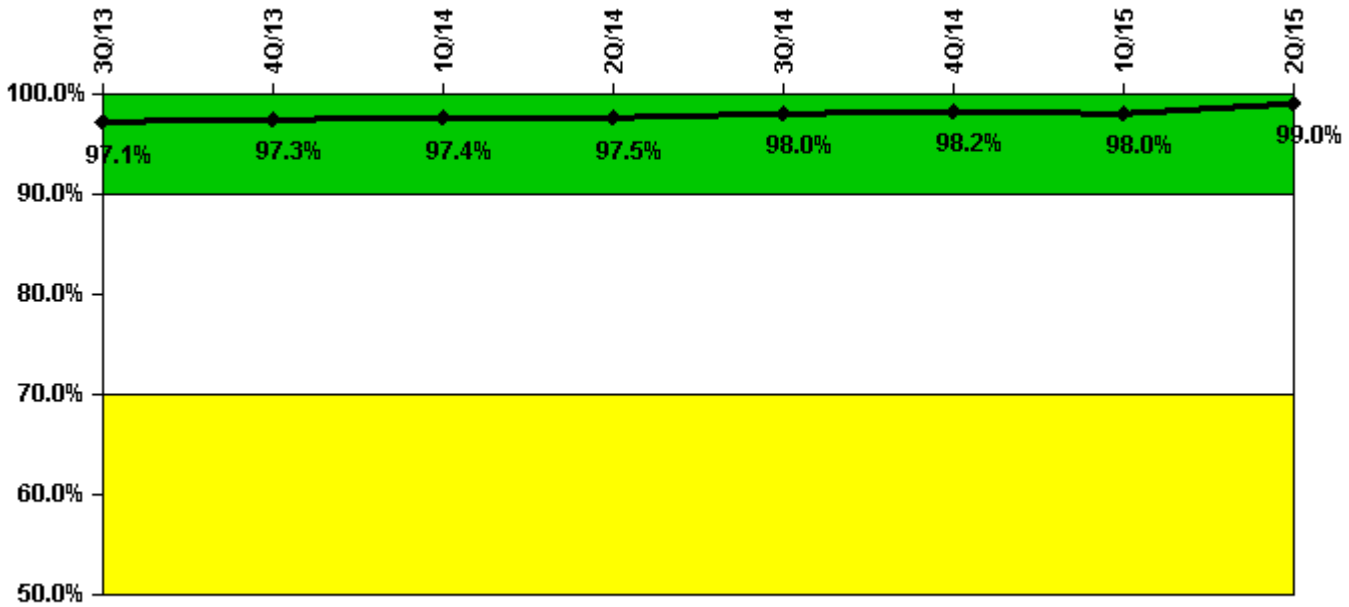

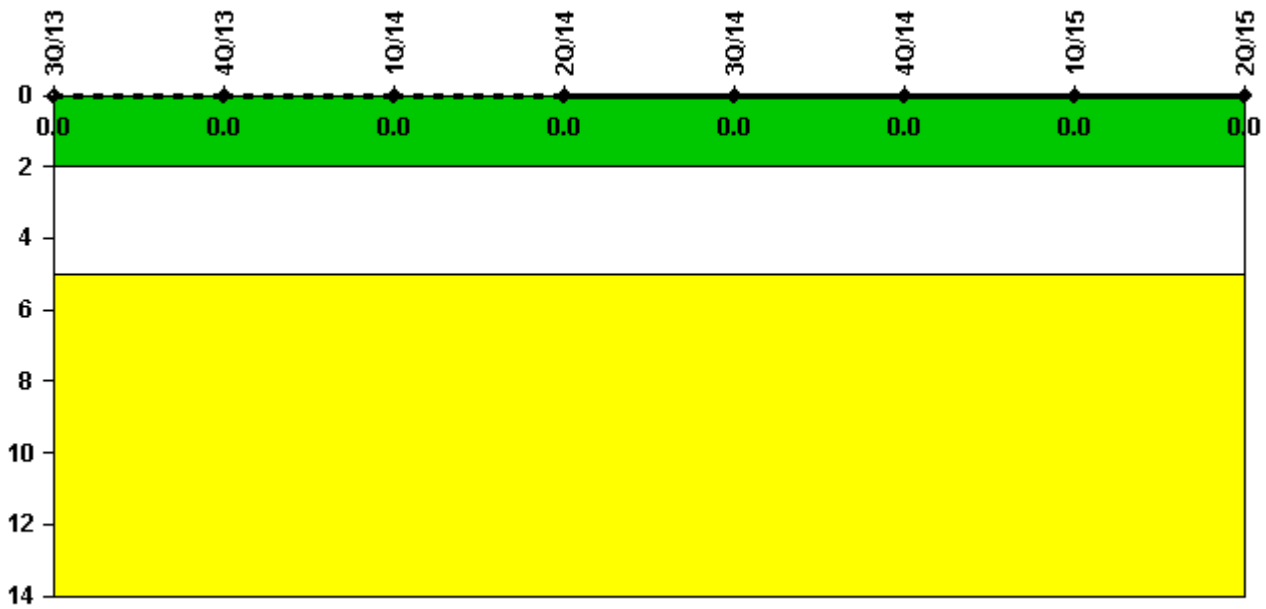

Occupational Exposure Control Effectiveness



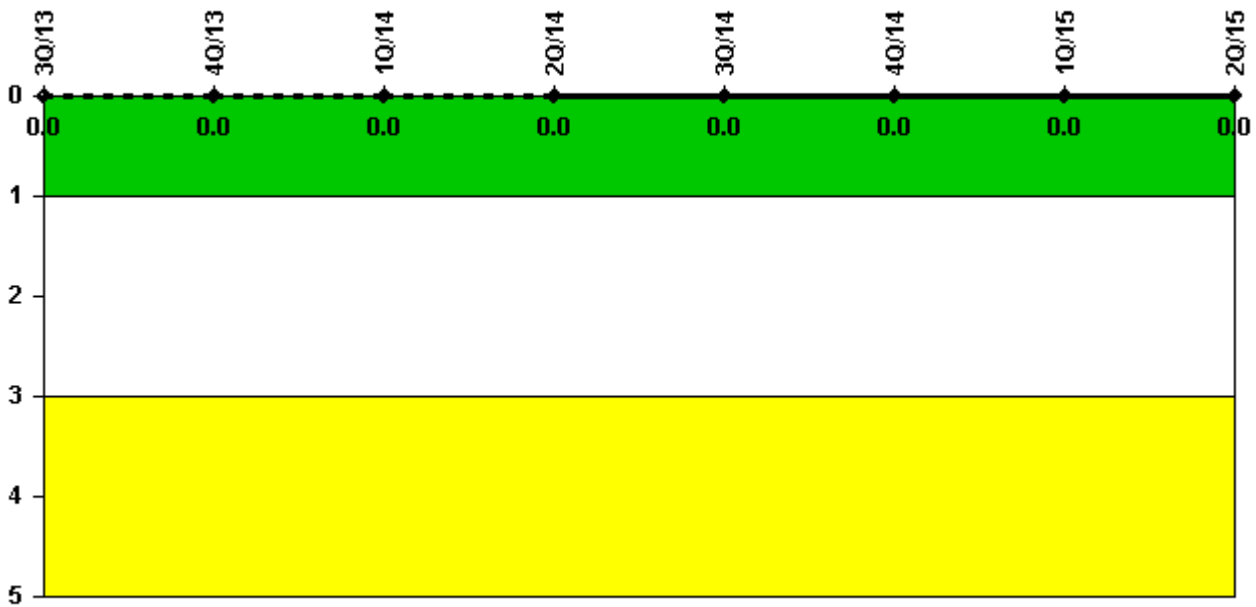
