

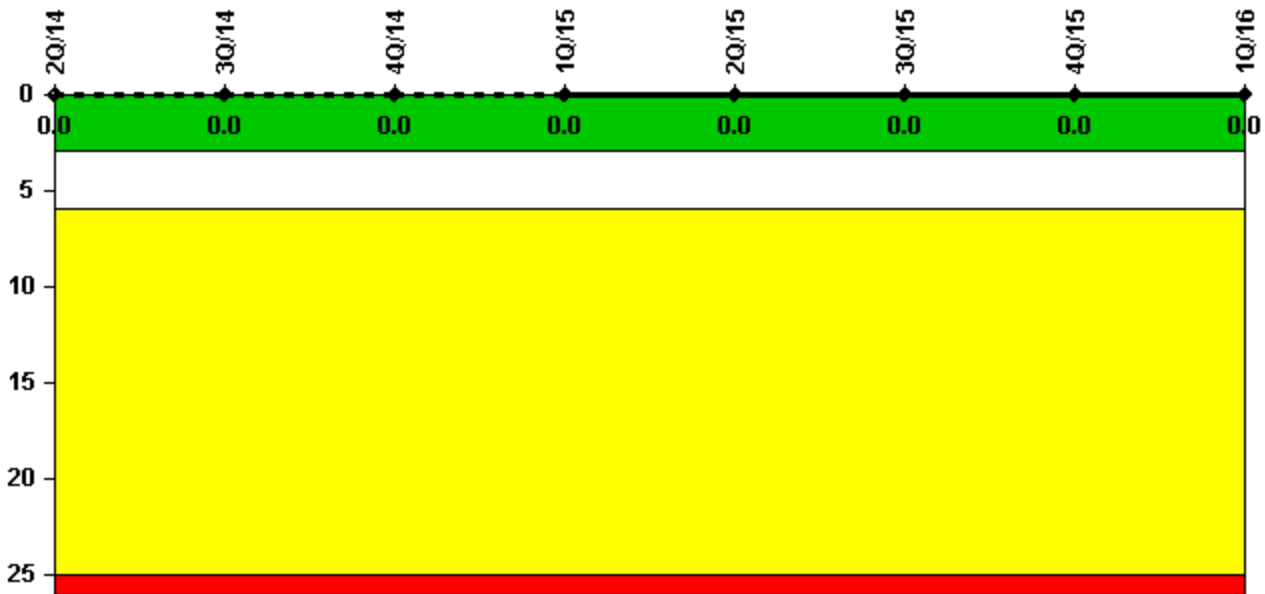

Unplanned Scrams per 7000 Critical Hrs



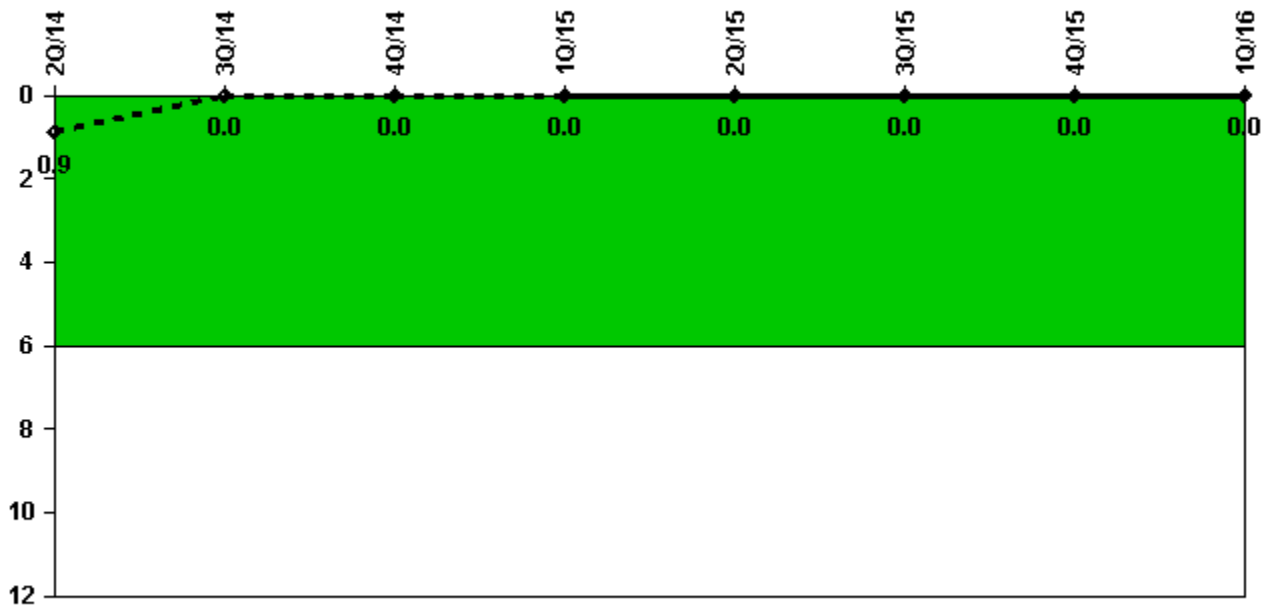

The planned unavailability baseline for the Cooling Water System 1 (Service Water System) overboard valves was reduced to reflect the current maintenance practice of not danger-tagging these valves closed for ice melt or during refueling outages (AR01670874). This change is consistent with how unavailability of these valves is treated in the PRA model.

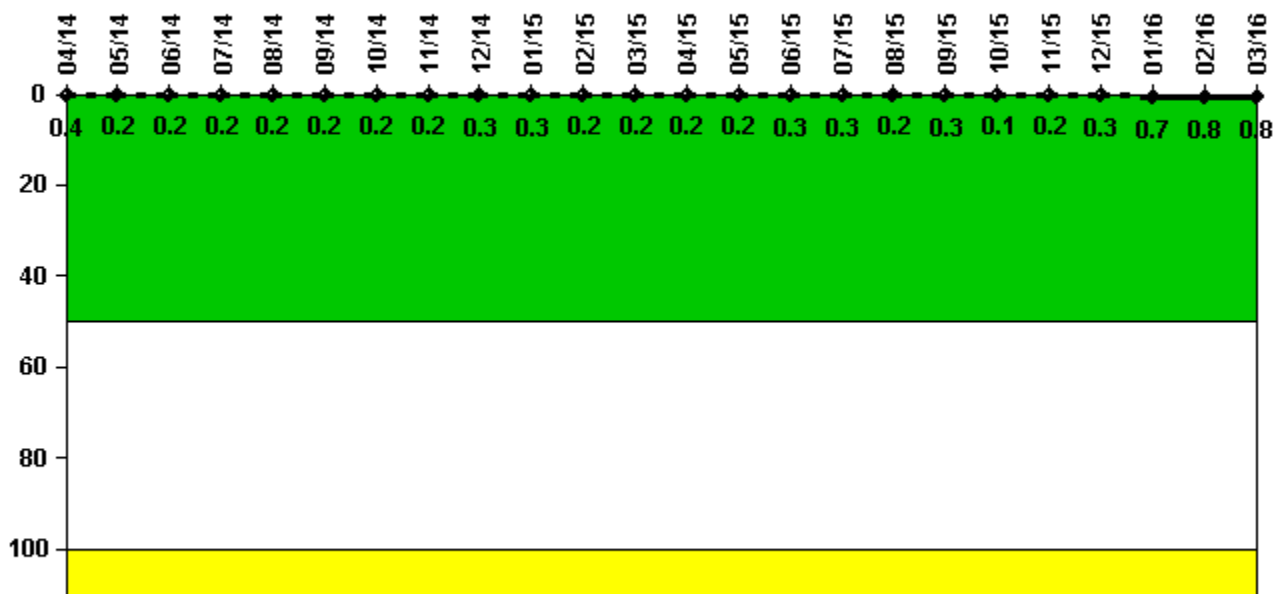

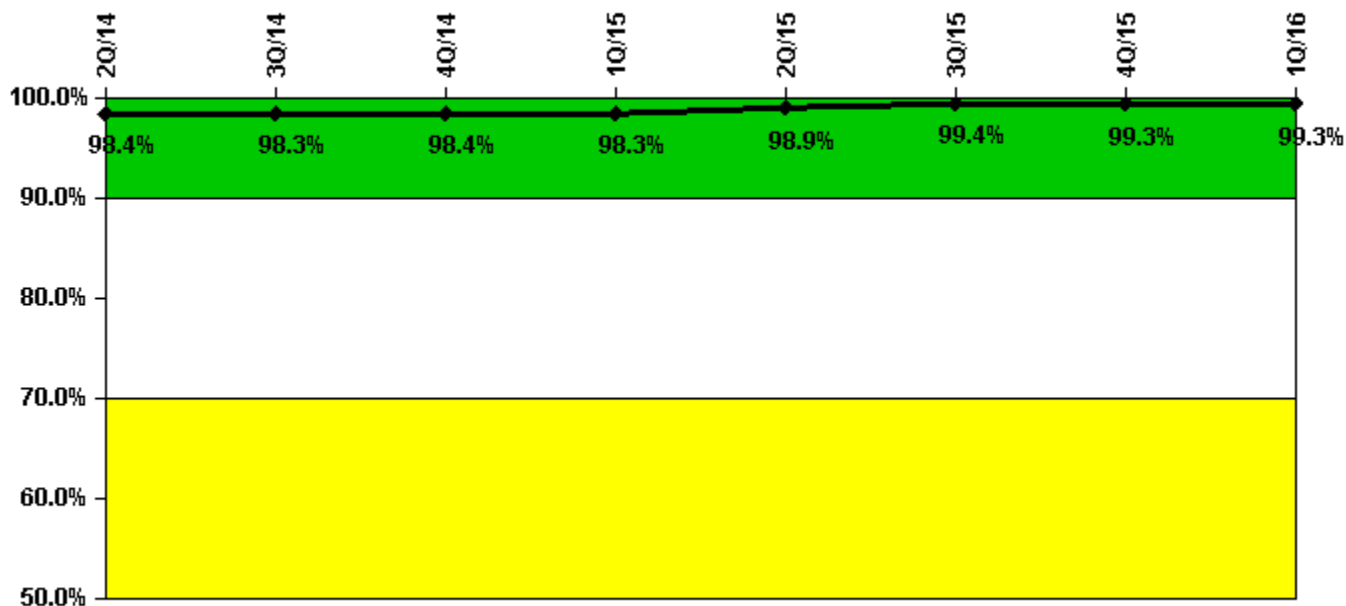

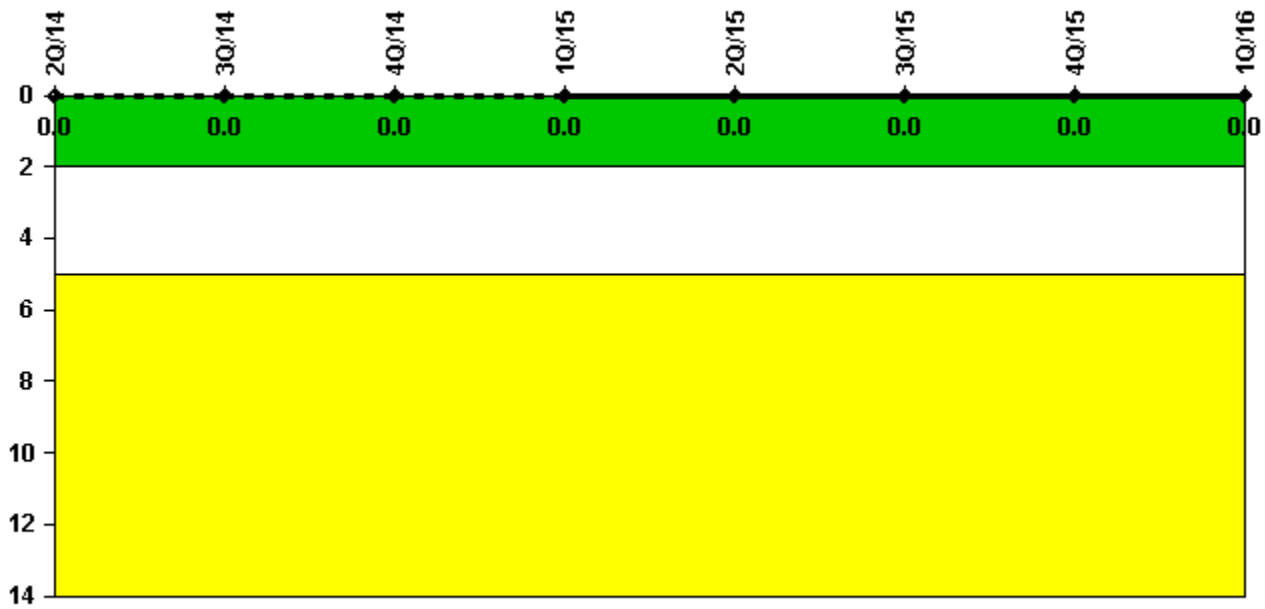

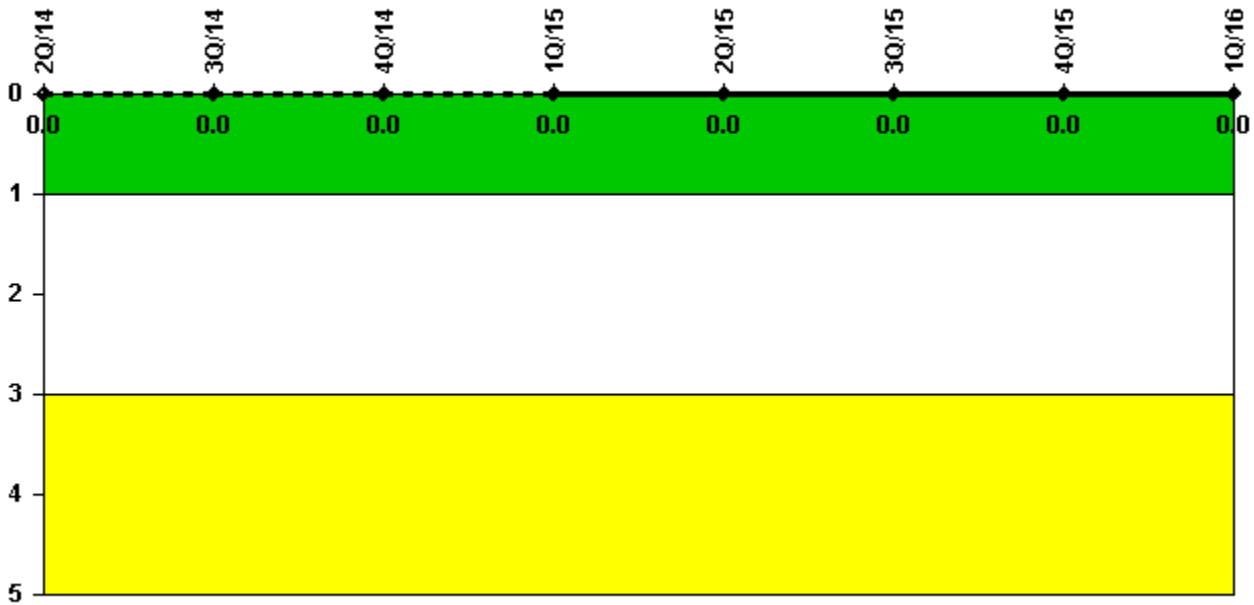
