SUBJECT: MID-CYCLE PERFORMANCE REVIEW AND INSPECTION PLAN - BEAVER
VALLEY POWER STATION, UNITS 1 AND 2

Dear Mr. Myers:

On November 7, 2000, the NRC staff completed its Mid-Cycle plant performance assessment of Beaver Valley Power Station, Units 1 and 2. The Mid-Cycle Review for Beaver Valley Power Station, Units 1 and 2 involved the participation of the responsible technical divisions in Region I in evaluating performance indicators (PIs) and inspection results for the period of April 2, 2000, through September 30, 2000. The purpose of this letter is to inform you of our assessment of your safety performance during this period and our plans for future inspections at your facility so that you will have an opportunity to prepare for these inspections and to inform us of any planned inspections which may conflict with your plant activities.

Plant performance for the most recent quarter was within the Licensee Response Column of the NRC's Action Matrix, based on all inspection findings being classified as having very low safety significance (Green) and all PIs indicating performance at a level requiring no additional NRC oversight (Green). We plan to conduct baseline inspections at your facility through September 30, 2001. In addition, we have scheduled a supplemental inspection to review the effectiveness of your corrective actions for the river water seal water design and testing issues, discussed in our May 3, 2000, letter to you. These issues were identified prior to initial implementation of the revised reactor oversight process and were considered risk significant because the potential existed for common mode failure of the river water pumps during periods of high silt conditions in the river, or failure of the pumps due to mechanical binding during colder weather.

Enclosure 1 details the scheduled inspections that will occur through September 30, 2001. The inspection plan is provided to minimize the resource impact on your staff and to allow for scheduling conflicts and personnel availability to be resolved in advance of inspector arrival onsite. Routine resident inspections are not listed due to their ongoing and continuous nature. The last six months of the inspection plans are tentative and may be revised at the end-of-cycle review meeting.
