On April 1, 2004, the NRC completed the onsite portion of an inspection at your H. B. Robinson Steam Electric Plant. Portions of our access authorization inspection were completed at the Progress Energy Corporate Office from March 2 - 4, 2004. The enclosed report documents the inspection findings, which were discussed on March 4, April 1, and April 28, 2004, with you and/or other members of your staff.

This inspection examined activities conducted under your license as they relate to safety and compliance with the Commission's rules and regulations and with the conditions of your license. Within these areas, the inspection consisted of selected examination of procedures and representative records, observations of activities, and interviews with personnel.
