



Draft Press Release and *Federal Register* Notice to Solicit Qualified Candidates for
Appointment to the Advisory Committee on Reactor Safeguards (ACRS)**

I approve of the draft *Federal Register* notice and press release to solicit qualified candidates for appointment to the Advisory Committee on Reactor Safeguards (ACRS) subject to the below modifications. The proposed notice and press release, in part, responds to the recent Commission decision to merge the Advisory Committee on Nuclear Waste and Materials back into the ACRS. The ACRS may be called upon to provide expert advice on matters previously under the ACNW&M. Thus, the *Federal Register* notice and press release should be revised to state that the ACRS may be requested to provide advice on radiation protection, radioactive waste management and earth sciences in the agency's licensing reviews for fuel fabrication and enrichment facilities, waste disposal facilities, and facilities related to the Department of Energy's Global Nuclear Energy Partnership.
